WITOLD TRAMPCZYNSKI  
JOZEF ANCZURA  
INTERNAL SECURITY - POLAND

All paragraphs herein are classified "Confidential"

Witold Trampczynski is assigned to the Polish Embassy,  
Washington, D.C. (WDC), as the Polish Ambassador to the United  
States. Jozef Anczura, formerly assigned as the Counselor-  
Consul General at the Polish Embassy, WDC, returned to Poland  
during July, 1976. Based on available information and/or  
investigation, Anczura is known to be connected with the  
Polish Security Service (SB).

On August 12, 1976, a confidential source who has  
furnished reliable information in the past advised that he  
had recently lunched with Ambassador Trampczynski at a local  
WDC restaurant. Trampczynski was in good spirits and mentioned  
that he would leave shortly on vacation to Canada. Trampczynski  
also commented that he would be returning to Poland sometime this  
year but that his successor had not yet been selected.

During the lunch, Trampczynski also commented that  
everyone at the Polish Embassy is delighted that Jozef Anczura  
had departed permanently as Anczura is a relic of prior times.  
Trampczynski noted that there would always be intelligence  
personnel at the Polish Embassy but they would not be as numerous  
or as blatant in their activities as before. Trampczynski also  
stated that there are not currently the number of intelligence  
associated diplomats at the Polish Embassy as was printed in  
the recent publication of Wolna Polska (Free Poland).
