1. PRELIMINARY ANALYSIS OF REF DOCUMENT INDICATES IT IS POLISH INTEL SERVICE (PIS) FORGERY DESIGNED TO RETALIATE AGAINST "FREE POLAND" (FP). FP IS RIGHT WING EMIGRE ORGANIZATION WHICH DURING PAST YEAR HAS EXPOSED AS ALLEGED INTEL OFFICERS MANY POLISH, SOVIET AND CZECH OFFICIALS, MOST STATIONED IN UNITED STATES.

2. POLISH GOVERNMENT HAS BEEN SERIOUSLY CONCERNED ABOUT FP'S ACTIVITIES BECAUSE ORGANIZATION ALLEGEDLY CONSISTS OF RECENT EMIGRES WHO ARE INCLINED TOWARDS AGGRESSIVE ANTI-COMMUNIST MEASURES, POSSIBLY INCLUDING TERRORISM. UNFORTUNATELY, PIS APPARENTLY SUSPECTS FP HAS CIA AND FBI CONNECTIONS AND MAY BE FORM OF USG RETALIATION FOR EXPOSURES OF CIA OFFICERS. THERE ARE ALSO INDICATIONS THAT PIS SUSPECTS FP HAS TIES WITH WEST GERMAN AND/OR ISRAELI SERVICES.
