INFORMATION ON EXPORT-IMPORT POSSIBILITIES

An export-import firm in West Berlin, owned by RICHARD FLESCHNER, \*1 age 32, single, Polish born Jew, German citizen, no police record, is actively and legally trading with the Soviets. The firm receives its orders directly from Moscow by telegram and all of its credits are handled by the BANK FÜR HANDEL UND INDUSTRIE in West Berlin.

Soviet requirements include, among others, electronic gear, complete production lines for poliomyelitis vaccine, and a complete centrifuge for aeromedical research. All requirements specify the country of origin, mostly United States or West Germany.

The largest Soviet requirement levied on FLESCHNER is the procurement of ten complete salmon canneries, costing approximately \$40,000,000 total. The Soviets were apparently unable to obtain these canneries in Canada. In April 1957, FLESCHNER stated, exploratory efforts in West Germany revealed that they could not be produced there for the next three to four years. Therefore, he wanted to be put in contact with a United States trade consultant. He was then put in contact with A. W. JACOBS, head of the JAY H Company, 4408 Manchester Avenue, St Louis 10, Mo.

JACOBS had just made plans to visit Europe to explore the possibility of trade with Poland within the framework of the \$90,000,000 U.S. loan to Poland. He arrived in Berlin in early July 1957 and was introduced to FLESCHNER by Spalinger, who was present at all of their meetings and acted as translator when necessary. FLESCHNER furnished JACOBS with complete Soviet specifications for the salmon canneries in the hope that JACOBS could get U.S. Department of Commerce approval for their export from the U.S. In addition, he turned over an order for shoes, clothing, radios, bicycles, etc., to JACOBS. These consumer goods were to be exported directly from the U.S. to the U.S.S.R. if legally permissible. The long range concept is to attempt establishment of a Soviet operated mail order store supplied with U.S. goods. JACOBS felt that he could arrange for Export Licenses through his contacts in the Commerce Department.

\*1 - Reference page 15, EXPORT CONTROL, Thirty-seventh quarterly report, Third Quarter 1956, by the Secretary of Commerce, RICHARD FLESCHNER and HANS WOLFF, both of West Berlin, were temporarily suspended from participation in all U.S. exports pending Commerce Department investigation of reports that they had been attempting to tranship three U.S. passenger cars, five U.S. trucks, and two cases of automotive equipment from West Germany to the U.S.S.R., despite advice by U.S. officials that this unauthorized diversion from FLESCHNER, supposedly the ultimate consignee, was illegal. FLESCHNER told Spalinger he had been suspended for one (1) year as a result of this.

Present Employment - MARIANNE MELEMEYER is presently assisting a West Berlin Export-Import trader who apparently has excellent contact with Soviet Trade delegations visiting West Berlin. She usually accompanies the Soviet Trade delegations on their shopping trips in West Berlin.

Pay - Source worked for ATILCO for expense money only. She is a very dedicated person.

Additional Information - Source reported during the months of July and August 1957 that Soviet Trade Delegations arriving from Moscow strongly indicated their desire to get in touch with U.S. manufacturers in order to purchase. The first order would be in the amount of \$10,000,000 approximately. The Soviets hoped to let contracts by December 1957.

MARIANNE MELEMEYER is in need of an U.S. outlet which could furnish catalogues and information on pertinent export data.

CONSTANTIN SIEGFRIED von HANFF

Spalinger met HANFF in July 1957 in FLESCHEMER's office in West Berlin. HANFF had come to FLESCHEMER's office as a result of FLESCHEMER's inquiry to Europol, Export-Import, 11 Wolfstrasse, in Cologne, regarding the possibility of opening an office in Poland.

During this meeting Spalinger posed as a representative of the JAY H Company, desirous of opening offices in Poland. Feigning curiosity, he asked if he could see HANFF's passport, since he had never previously had access to a Polish passport. HANFF acquiesced and as Spalinger idly leafed through HANFF's passport, he noticed that HANFF had practically carte blanche permission to travel freely to and from Poland to any country in Europe.

Subsequently Spalinger contacted HERBERT BIENE, \*1 a West German national employed in the West Berlin Police Department in the Foreign Travel Section, and queried him regarding HANFF. It was BIENE's feeling that HANFF must be an STB employ since only persons in Security Police or very high government positions would have such a passport.

 after this, Spalinger made a concerted effort to cultivate HANFF. As a result of this effort, HANFF finally admitted to Spalinger that he was an employ of the STE and not an ordinary exporter-importer, such as Spalinger. HANFF then persisted in an attempt to sell Spalinger the services of an alleged intelligence net which he had in Poland, or to perform other services for Spalinger of an intelligence nature for reimbursement. Spalinger demurred but HANFF persisted. HANFF allegedly desires to bring his wife and son out of Poland but only when he has acquired sufficient money to ease the shock. HANFF had recently become a Polish citizen. He was born in that part of Germany appropriated by Poland after WWII.

Finally, on August 16th, 1957, he prepared the inclosed document in his own handwriting (translation attached) for Spalinger, to demonstrate his complete seriousness in this matter.

among other things, HANFF claimed he could obtain an MIG 17 engine. Spalinger stated that he was not interested in an intelligence operation as such; however, he did think that HANFF could possibly be paid if he could secure technical orders and other documents of this nature pertaining to Air Force equipment.

The inclosed photographs are copies of a photograph given to Spalinger by HANFF to deliver to HANFF's mother in New York. HANFF's parents are divorced and his mother has reassumed her maiden name.

JACOBS, of the JAY H Company, has not met HANFF, nor is HANFF a carded source or known to any U.S. intelligence agency.
