<p>1. This will serve as a routine reminder that all three of the Subject Project renewals expire at the end of June and are due in Headquarters by 1 June.</p>																																					
<p>2. We are now agreed on the basis of the first two references that HARVARD will be submitted this year, and hereafter, as a part of Project CABEZONE. We wish to take this occasion to urge again that CAMANTILLA also be included.</p>																																					
<p>3. One reason for including CAMANTILLA with the others is that the prime activity for which we are paying under this Project takes place right in Frankfurt, as reflected in paragraphs two and three of the third reference. This activity is most easily kept tabs on in the course of the virtually daily contacts CSB maintains with the Frankfurt Office; these represent the vast majority of the direct contacts needed between our Organization and CAMANTILLA. Headquarters' functions have been and are limited to three routine support activities: our subsidy is routinely channeled to the New York Office through Finance on a quarterly basis; CAMANTILLA accountings are routinely forwarded through KUVEST to Finance; and the Desk maintains occasional contact with the New York Office for administrative and support purposes. In our view, these facts characterize CAMANTILLA as being primarily a field type Project.</p>

A still more important reason for combining the three Projects into one, however, is that we believe both KUDOVE and KUBARK management have not only the right but the requirement to see our defector and resettlement activities as an integrated whole during the approval process and to be aware of the total cost of this activity. This is not happening now. Until this year the three activities have been processed and have gone forward as separate Projects, two of them separately for approval by the Assistant Chief, KUDOVE and one for approval by the Deputy Chief, KUBARK. To remedy this situation we strongly desire to renew all three activities this year under Project CABEZONE with budgets separated so that costs of each activity can be easily distinguished but with a single total of expenses for all three.
