- ii. 11 Nov 1945 - 29 Jan 1946, Jail in BOLZANO and MILAN. Escaped while enroute MILAN-PARMA.
- 16 May 46 - 20 Jul 1946 Apprehended and jailed in Rome, escaped 2 June 1946 but was apprehended one day later and sent to GI Camp, RIMINI. Escaped 20 Ju 1946.
- RIS INPUT NO. 35
- 27 Aug 1946 - 15 Jun 1947 Apprehended and incarcerated in ROJ on 27 Aug 1946 where he remained for seven months. Sent to GI Camp RIMI when after three months he escaped again.
- Jun 1947 - Dec 1947 Subject taught religion in a Catholic Institute in FERMO, below ROME.
- In December 1947 subject was brought to CIC Austria and became operator of network "LOS ANGELES", working out of ROME, Italy. Subject has remained in this capacity ever since.

20. (a and b) 10/6369 was apprehended by the undersigned in November 1945 in Bolzano, Italy. After a preliminary interrogation, source was transferred to the custody of the British SOI. Source began a series of six escapes which are chronologically listed in paragraph 11 of Control Data Form I. CIC Rome apprehended subject on three different occasions and finally, because both were tired of running and arresting, a peace pact was made in which he would devote his talents and energies to the benefit of CIC. Because of the closing of the Italian Theater, CIC Agents suggested that he be brought to Austria where he could continue his work. This proposal was agreed to by the CO 430th CIC Detachment. On 11 November 1947, subject was transferred across the Italian-Austrian border and taken to Linz, Austria and placed in the custody of the CO, 430th CIC, Linz Detachment. (In December 1947, the undersigned assumed operational control of 10/6369)

(a and b) Source was to remain in CIC Gmunden Billets for the purpose of drawing up a list of contacts, methods of communication, safe havens etc. After a four-month sojourn, source was to go to Rome as the key operative of a penetration net with the mission of collecting PCI information, activities of other intelligence agencies, political and economical situation in Italy.



- d. All above mentioned sources are contacted by the key operative in bars, offices, cafes, homes, etc. Information is gleaned from Agents of other Intelligence Agencies operating in and around Rome. However, with the new requirements, subject is developing sub-sources in Genoa, Milan, Turin and Bolzano.
- e. Control Agent personally contacts key operative between the fifth and tenth of each month. Meetings are effectuated in Rome or a city located at the Austrian-Italian border. Each report submitted by Source is discussed on the spot in an attempt to discard any information which is out-dated or superfluous. Prior to Control Agent's departure from the meeting place, a month's supply of paraphrased EEI's is submitted to the key operative.

27. Seventeen years of intelligence activities covering all fields, including Director of T/W Agents' school in Parma, Italy, from where he dispatched his agents into A.O.T. 10/6369 has been assigned non-intelligence collection mission (i.e. disposition of sensitive persons). These missions were accomplished successfully.

29. Key operative is a German national and would like to cast his lot with the existing BONN government. He recently told the undersigned that he had been approached by a personal representative of ADENAUER in Italy, as to key operative's possibilities of joining the Bonn Government at some future date; presumably in the capacity of an intelligence operative.

30. Due to key operative's reutonic rearing and twelve years as a main cog in the various SO offices, subject is methodical and analytical not only in the processing of information given to him, but also in his personal contacts with people. He is logical and conclusive and never deviates from his mission or purpose. He is given neither to bragging nor to exaggerated importance of himself.

Subject's long series of escapes from CI Camps have been narrowing experiences and on three different occasions only his physical courage saved him from permanent injury or death.

As a German field grade officer in the SD, subject has access to the "first families" of Rome, Paris, Rotterdam, Berlin. As an escaped PW, source descended into the level of farmer's helper contenting himself with a mere pittance. By diligently applying himself and selling his talents (subject holds a degree in Political Science from the University of Berlin) subject obtained a position as an Italian teacher to young boys in an Italian school. It might be said that the vicissitudes of life have shunted subject into all strata of life so that today he can adopt himself to any groups of people or any existing condition.

RESTRICTED

33. Subject is completely dependent upon the undersigned for the validity of his identity documents. He knows that any undue or suspicious action on his part would cause him and his wife to be cast adrift in Italy without proper documentation, which would then subject him to be deported to a refugee camp. In view of the fact that bona fide documentation is a prerequisite for personal safety reasons, it is felt that no further control measures need be developed.
34. No definite commitments have been made to 6369. However, in the event that subject should be evacuated or compromised to the extent that he should leave Italy, it is proposed that subject be given a lump sum of money so that he and his wife might start life anew in another country. It is felt that subject is due that much since he has served this organization loyally and faithfully for three years.

Personal data was obtained from personal observation and association with subject over a period of three years.
