INTEL

1. BELIEVE REF DIRECT TIE-IN WITH [] 3850 (IN 35004). SIMILAR PROPOSAL TO GRIESER (PARA 5 REF) PROBABLY MADE BY HASS. ENTREE IN REF INDICATES MINISTRY BLANK (READ HEINZ) MAKING MULTIPLE EFFORTS TO RE-MOUNT OPS ACTIVITY IN AND THRU ITALY.

2. COL. HEINZ KNOWN "I" CHIEF IN MINISTRY BLANK AND IS NOT PART OF ZIPPER NOR IS HE CONTROLLED BY DYCLAIM. BLANGG BELIEVED AN ALIAS FOR HEINZ SUBORDINATE. FOR FIELD INFO, IN DEC 51 HOETTL APPROACHED HASS STATING HE SETTING UP MEDITERRANEAN INTELLIGENCE NET FOR HEINZ. AT THAT TIME STATED HE AND HEINZ WOULD GO TO ROME IN FEB 52 TO SET UP FORMAL LIAISON THRU VON BRENTANO. NOW APPEARS THIS COURSE NOT BEING FOLLOWED AND HEINZ BUSY WITH PRIORITY TASKS AGAINST BALKAN TARGETS VIA TRIESTE. CURRENT HEINZ MEDIT EFFORTS BELIEVED ATTEMPT TO ENTRENCH HIMSELF WITH BLANK MINISTRY AS KEY FUTURE GERMAN IS OFFICIAL.

3. CASEINOF FNU PROB I/W NIKOLA MAXIMOFF (SEE [] 2227, 22 MAR 52) HE AND WIFE HAVE HAD WIDE "I" CONTACTS, INCL POSSESSION OF W/T SET RETRIEVED BY LUONGO FOR ZIPPER IN 1950. NO ZIPPER CONTACT SINCE THAT TIME. SINCE REF IS FIRST INDICATION HE AND WIFE "R" OFFICE INFORMERS, ITALS PROBABLY KNOW OF ZIPPER DEALINGS AS WELL AS LUONGO, B.I.S. AND OTHER CONTACTS OF MAXIMOFF AND WIFE.

4. PARA 6 REF INDICATES GOOD ITAL CONTAINMENT OF HEINZ-HASS EFFORTS. WE HAVE CONTINUING INTEREST ALL GERMAN IS ACTIVITY ITALY, BUT NO DYCLAIM ASSETS YET INVOLVED.
