1. IN CONVERSATION WITH KARL HASS 30 SEPT ULDERIGO CAPUTO INSTRUCTED FORMER BREAK ALL CONTACTS WITH BIS DESPITE HASS DENIAL THAT SAME EXISTED.

2. CAPUTO EXPLAINED REASON FOR ABOVE INSTRUCTION FACT THAT JOSEPH LUONGO HAD RETURNED SALZBURG AND HAD ALREADY CONTACTED CAPUTO WITH WHOM DEVISED PLAN INVOLVING USE OF HASS AND LATTERS EVENTUAL COLLABORATORS. ON THIS SUBJECT CAPUTO HAD CONVERSATION WITH COURIER SENT FROM AUSTRIA BY LUONGO, FOLLOWING WHICH CAPUTO VISITED HASS TO RECOMMEND LATTER NOT BREAK OFF BORN SERVICE CONTACT FOR ANY REASON. HASS INFORMED CAPUTO THAT HE HAD OPENED LAST POUCH FROM BORN TO SEPAR. CAPUTO APPROVED THIS ACTION.

3. FOLLOWING HASS HYPOTHESIS MEANS BY WHICH CAPUTO LEARNED OF RECENT HASS-BIS TALKS:

A. CAPUTO BRITISH AGENT WHO CONSULTED BY BIS RE HASS PRESENT POSITION AND RECRUITMENT POSSIBILITY. HASS STATED BIS MAY HAVE INSTRUCTED CAPUTO ESTABLISH HASS-LUONGO CONTACT WITH INTENTION MAKING HASS UNWITTING BIS INFORMANT THROUGH CAPUTO.

RIS INPUT NO. 35. HANS GIESSAUF, PROPRIETOR WIENER BIERSTUBE, VIA DALLE GROCE 21, HAD REPORTED HASS CONVERSATIONS WITH MEMBERS BIS WHICH TOOK PLACE ON PREMISES. ACCORDING HASS, GIESSAUF THEREFORE INTERIOR OR QUESTURA INFORMANT.
