1. NOTHING NEW LEARNED SINCE REPORTED HASS CONTACT WITH SOVIETS. SINCE THAT TIME H APPEARED LOSE ALL INTEREST ANY INTEL ACTIVITY, STATING HE EXTREMELY DISILLUSIONED AND INTENDED CUT OFF ALL CONTACTS. IMMEDIATELY AFTER MEETING SOVIETS, H INVOLVED INTENSE COMMERCIAL ACTIVITY SELLING TOYS FOR HOLIDAYS AND WAS EXTREMELY BUSY (1 DEC THRU 15 JAN).

2. [] HAD FREQUENT CONTACTS WITH H THIS PERIOD AND HAS ACTIVE REVEAL H HAD NO CONTACTS OUTSIDE HIS COMMERCIAL ACTIVITY, WOMEN AND COGNAC. SUCCESS H COMMERCIAL VENTURE DUE LARGE PART TO PARTNER EMBKE WITH WHOM H RESUMED RELATIONS SPENDING ALMOST ALL FREE TIME WITH HIM LAST TWO MONTHS.

3. RECENTLY (EARLY FEB) H INDICATED CERTAIN INTEREST IN OLD INTEL CONTACTS, DEVELOPMENTS OF WHICH WILL BE FOLLOWED. THIS REVEALED INTEREST DUE FACT BUSINESS AFFAIRS NO LONGER OFFER SATISFYING PROFIT NOW CHRISTMAS HOLIDAYS. H ACTIVITY CONTINUES BE FOLLOWED AND CONTROLLED THRU []

4. UNCLEAR ARE RELATIONS BETWEEN EMBKE AND STEIN CO (FIELD COMMENT: FIRM IN ROME WHICH HANDLES, AMONG OTHER THINGS, PACKING AND SHIPPING AMEMBASSY EMPLOYEES EFFECTS). STEIN ADVANCES PAYMENT EXPENSES FOREIGN BILLS OF H FIRM AND GETTING MERCHANDISE OUT OF CUSTOMS, ACCEPTING FROM EMBKE DRAFTS AND CHECKS HE RECEIVES FROM ITAL CLIENTS WITHOUT CHARGING INTEREST THEREON. THIS NOT CONSIDERED NORMAL SITUATION WHICH ACCORDING SOURCE IS INEXPLICABLE.

5. ON 8 FEB C ACCOMPANIED EMBKE AND H TO STEIN'S TO WHOM THEY OWED 300,000 LIRE ON CHECKS WHICH HAD NOT BEEN COVERED WITHIN ESTABLISHED TIME LIMIT. E AND H REQUESTED MONTH EXTENSION WHICH SMILINGLY GRANTED. H VERY SUSPICIOUS THIS ATTITUDE WHICH HE ATTRIBUTED TO SPECIAL AGREEMENTS OF INTEL NATURE BETWEEN STEIN AND E. SOURCE INVESTIGATING STEIN, RESULTS TO BE REPORTED.
