1. ITALIAN CS OFFICIALS NOTIFIED  OFFICE THEY EXPELLING KARL HASS BECAUSE OF UNRELIABILITY. HASS APPARENTLY VICTIM OF INTRIGUE BETWEEN DEFENSE AND INTERIOR MINISTRY OFFICIALS. ITALIAN CS REPRESENTATIVES NOTIFIED CARRY VIA FOREIGN OFFICE THAT HASS AND BROTHER OF UTILITY PEDDLING INTELLIGENCE OBTAINED FROM ITALIAN SERVICES TO FOREIGN SERVICES.
2. HASS WAS ZIPPER CONTACT AS WELL AS CAPOTE CONTACT, ALLEGEDLY ALSO IN CLOSE CONTACT WITH BROTHER OF UTILITY. FOREIGN OFFICE NOTIFIED CARRY THEY RECENTLY RECEIVED COMPLAINT IN ROME THAT BROTHER OF UTILITY ALSO INVOLVED IN HASS SALE OF INFORMATION TO FOREIGN SERVICES AND ARE PREPARING OFFICIAL PROTEST TO BONN.
3. ITALIANS ALSO REPORT HASS HAS PURCHASED TICKET FOR ARGENTINA.
4. DEFENSE MINISTRY HAS LONG BEEN TRYING TO GET RID OF HASS.
