Subject is a former Latvian Army officer who carries on an extensive correspondence with his former army colleagues, some of whom reside in the Latvian SSR. We intend to utilize Subject's correspondence channels for the procurement of FI and PP intelligence. Subject will also be utilized in the procurement recruitment of his officer colleagues in Latvia as operational assets there.
