Personal History:

(to be handwritten, and in detail)

I was born on 2 April 1902 in Neudorf, Kreis Schubin (now Poland), as the son of Emil Hein, then owner of an estate, and his wife Elise née Boelter.

From my 7th to my 10th year I attended the Preparatory School in Zempelburg (West Prussia), and then the Realgymnasium in Bromberg. I passed final examinations of that school in June 1921. From July to 1 December 1921 I was an employee of the Vereinsbank (banking institution) in Thorn. Until March 1922 I lived on my father's estate, and then I emigrated to Germany. I began my legal studies in Berlin during the summer term 1922. As I had to earn my living while a student -- my parents had also emigrated and had lost their property -- I had several teaching jobs in Berlin, and between terms I worked in a factory in Westeregeln near Magdeburg. I succeeded in obtaining a permanent job from 1 January 1924 on with the firm Transradio A.G. in Hamburg. However, on account of the Law on Reduction of Personnel I was discharged on 1 July 1925, and as I was unable to find another job, I was forced to give up my studies at the university in Hamburg. I was unemployed until 1 October 1925 on which day I joined the Schutzpolizei in Hamburg. I was a member of the Hamburg Schutzpolizei until February 1932; my last rank was that of Polizei-Zugmeister. In February 1932 I was transferred to the Kripo (Criminal-Police), and in March 1933 to the Stapo (State Police) in Hamburg, where I remained until January 1938. Then I was transferred to the Stapo in Koblenz, and in September 1938 to the Stapo in Kiel. In July 1938 I was appointed Kriminal-Kommissar, and I still hold that rank in my present assignment.

I have been a member of the party since May 1933; of NSV and RLB since 1936.
