Is identical with Oskar HEIN, subject of ODIBEX Consolidated O31 Interrogation Report, 17 June 1945, from which we have excerpted the following key information:

Former Kriminalrat, RSHA, who was arrested 7 May 1945 in Schwerin.

Personal Description: Height 1.77 cm, hair reddish blond, blue eyes, high forehead, oval face, drawn features, pale complexion, slim build.

Languages: French, English. Can translate from these languages into German. Cannot speak fluently for lack of practice.

Wife: Ilse, nee GRADERT

Children: One boy, age 5 months.

EARLY HISTORY:

- Born: 2 April 1902 at Neudorf, Kreis Schubin, Warthegau. On the transfer of this territory to Poland after the war 1914-1918, he opted for German nationality.
- 1919: Attended the Realgymnasium at Bromberg and took his Abitur there.
- 1923: In 1923 studied law for 5 semesters at Berlin and Hamburg, but had to end his studies for financial reasons. Went to work in the Teleprinter Dept. of Transradio Corporation Hamburg. Was unemployed in 1925 and joined the ORPO Hamburg as a Hilfswachtmeister.
- 1932: In January 1932 was sent to the Kripo Hamburg as a Kommissaranwaerter in the Fraud and Theft Dept.
- 1933: In April was sent to the Stapo Hamburg, where he remained until January 1934. Was employed in the department of Economics, later Press, and eventually had to vet workers for armaments industry.
- 1938: In January went to the Stapostelle Koblenz where he dealt with homosexuality
- 1938-1939: From September 1938 to September 1939 was at the Stapostelle Kiel in charge of the Economics branch and later church matters.
- 1940: From the outbreak of war to April 1940 he was in Poland, chiefly in the counter-espionage branch.
- 1940-1941: Worked for the Auswertungsstelle Frankreich, a Sonder Kommando of Ambt IVB of the RSHA from 1940 to 1941.

In June 41 he returned to Schwerin, where, in addition to his former duties he had charge of the passports and frontier section. For a short time he supervised the department dealing with V-men. He was at Schwerin until September 44 except for an 8-day SS officers course in Weltanschauung which he attended at Prague in May 1942. He became a Hauptsturmfuehrer.

Sept. 1944- With Amt IV, RSHA
onwards

27 April

1945: Gave himself up.

Subject proved a willing and useful informant, who gave a detailed picture of the set-up for Amt VI-B. RSHA.
