On September 3, 1963, Prut Parming, 473 Luhmann Drive, New Milford, New Jersey, advised that in 1961 he traveled to Canada with his mother. She at that time was handling a girls gymnastic festival in New York and went to Canada to handle the training and to rehearse the Estonian girls there who were to take part in the festival. While there he met EERIK Heine through a mutual friend whom he identified as Captain Juri Martinson. The latter he stated is a regular Army man who recently returned from a tour of duty in Germany and is now assigned as an ROTC instructor in a college in upstate New York.

Prut Parming stated that he was desirous of meeting Eerik Heine inasmuch as he had heard that he was experienced in guerilla warfare in which he himself had a great interest. He stated that on the occasion of their meeting he asked Heine to write of his personal experiences and therein to give in detail the tactics he witnessed and utilized while engaged in guerilla warfare against the Russians. He stated that Heine never did write of his experiences as requested. However, they did correspond and he has learned in detail of Heine's background as he has related it in lectures, writings and in personal conversations throughout the United States.

Prut Parming stated that Heine on request did furnish him tape recordings concerning guerilla warfare tactics, but to date he himself has not had time to listen to them and evaluate them. He stated that they have been made available to a representative of the United States Army and the content analysed as to military value.

Prut Parming stated that he has learned that Heine is in the United States at this time and that he is next scheduled to speak at the New York Post of the

Estonian Veterans Organization, located at the Estonian House, 243 East 34th Street, New York City, on September 7 and 8, 1963. He stated that he will speak at the invitation of the Post Commander Keerd. He stated that he is unaware of future engagements of Heine at this time.

Prut Panning stated that due to what he believes are discrepancies in the background of Heine, as told by him he is of the belief that Heine is either an "extremely high class intelligence agent or psychologically trying to live up to the role of a hero". He stated ~~that the discrepancies in his stories are minor ones~~ and due to the lack of information available it is possible that Heine is telling the truth about his experiences. In view of the discrepancies, however, he stated he has his own reservations concerning him.

Prut Panning stated that he has no knowledge that Heine has the intention of becoming a citizen of the United States, but has heard that he has talked of wanting to join the Special Forces Service of the United States Army.
