SUBJECT: 17 December 1963 Meeting with Juri RAUS

1. Undersigned met with RAUS on 17 December 1963 from about 1600 to 1930 hours in a downtown cafe. Mrs. RAUS participated in the meeting.
2. The following items were discussed:
 - a. Undersigned paid \$140.00 to Mrs. RAUS (the remaining \$21.70 was mailed on 21 December by postal money order) for typing performed (cards) and for translating the Tartu University handbook.
 - b. Subject called attention to the fact that the name of

Kardu LOO

appeared in the Tartu University as the authoress of a book which is now out of print.
 - c. Recently, Subject's wife has received several phone calls from an unidentified party who tried to cast aspersions at Subject's loyalty toward his wife. According to Subject, he has reported this to his FBI contact.
 - d. The following pertains to E. HEINE:
 - (1) Subject received a letter (which he displayed to the undersigned) from the LEL Chapter in Detroit in which all the Chapter LEL officers agreed with Subject's position on HEINE in refusing to support him or to maintain contact with him.
 - (2) Subject reported that

Meemi MELGI,

a member of the ENC at the present time, a former school teacher by occupation, has actively begun spreading various rumours to the effect that Subject and others will be taken to court for having denounced HEINE, MELGI, formerly a resident of Minneapolis, Minnesota, is now a violin maker who commands a high salary for his unusual abilities in this conjunction. Subject admitted that he had mailed to MELGI one of his form letters which he

warned all to beware of HEINE. Subject characterized MELGI as an individual who is usually pretty stable. However, apparently because Subject had generally ignored MELGI and had not consulted him when he was on the LEL Council, MELGI sought out TIIVEL and reported that "BAUS and other will be arrested for denouncing HEINE." MELGI has likewise denounced Subject to the Cleveland Rifle Association where MELGI is still active in some capacity.

(3) Subject learned from

Gunnor PAABO,
lives Baltimore, Md.,

that

Voldemar KUNNAPA
born ca 1910 in Estonia,

recently received a letter from HEINE in which HEINE complains about the difficult situation he is in in view of the suspicions which are circulating about and around him. HEINE allegedly indicated that he was at a loss as to what he should do and then proceeded to ask KUNNAPA for his advice as to what he (HEINE) should do under the circumstances. KUNNAPA then indicated to PAABO that "the American who began this rumour about HEINE is in jail or will soon be arrested". Subject does not know whether the foregoing is original with KUNNAPA or with HEINE. According to Subject, KUNNAPA is a former schoolmate of HEINE. A former member of the Estonian police during the Soviet occupation, KUNNAPA allegedly helped HEINE escape from "Soviet prisons on several occasions". According to KUNNAPA, HEINE had been arrested by the Soviets more than once during the Soviet occupation.

8. During an LEL meeting in New York City

Vello PODRANG

volunteered to show various photographs in order to prove that HEINE had not been in the German school which he claims to have attended. However, only one other individual, other than PODRANG, showed up for the meeting.

(1) Subject asked that he be provided with an official letter from CIA in which he would be officially apprised of the existing suspicions against HEINE and which letter he could have reproduced in newspapers to "prove" to all that his (BAUS) position in suspecting HEINE has official sanction. Undersigned indicated that this would be impossible.

- f. [] Subject reported that [] during an interview in Tallinn with a Swedish left wing correspondent, accused the CIA of having killed

Heikko KARISMAN,

a seaman whom a CIA operative had gotten drunk. KARISMAN was then engaged in a fight by the CIA operative and thrown overboard. According to Subject, the most recent edition of the VES carried an article concerning this interview of []

- g. In reply to my query, Subject indicated that he was very poorly acquainted with the personal background of

Viktor JAANDETS.

However, Subject is quite certain that JAANDETS has never revealed to any Estonian emigre in the USA about his past activities as a Soviet IB internat agent and informant.
