- REF A, WHICH YOU WILL RECEIVE 12 JAN, ADVISES THAT EERIK HEINE BROUGHT SUIT AGAINST JURI RAUS ON CHARGE THAT LATTER SLANDERED FORMER BY DENOUNCING HIM AS SOVIET AGENT. REF^A ALSO STATES KUBARK ASSISTING RAUS.
- RAUS ATTORNEYS HAVE REQUESTED PRESENCE HEINE IN WASHINGTON ON 2 FEBRUARY FOR DEPOSITIONS.
- INTERNAL REVENUE SERVICE INTERESTED HEINE TAX LIABILITY FOR FUNDS COLLECTED DURING FILM SHOWINGS USA. HAVE JUST LEARNED IRS IS WRITING HEINE FOR EXPLANATION.
- IF KUBARK IS ACCURATE IN ITS ANALYSIS THAT HEINE IS IN FACT A SOVIET AGENT, BELIEVE PARA 2 AND 3 ACTIONS MAY FORCE HIM INTO PRECIPITOUS CONDUCT ESTABLISH CONTACT WITH SOV INTEL, POSSIBLY EVEN PERSONAL MEETS WITH LOCAL INTEL SUPPORT TYPES. ACCORDINGLY AFTER RECEIPT REF A YOU MAY WISH SUGGEST TO SMABOVE THAT MONITORING HEINE ACTIVITIES DURING THIS PERIOD MIGHT BE USEFUL AND PRODUCTIVE. ALSO SUGGEST COVERAGE POSSIBLE CLANDENSTINE RADIO CONTACTS.
