1. INFORMATION PROVIDED BY CAVATA IN REF B IS APPRECIATED,
AND AWAIT WITH INTEREST RESULTS THEIR FURTHER INVESTIGATION.

2. CLEARED ATTORNEYS HANDLING THIS CASE IN BEHALF KUBARK
REQUEST SUPPORT INTERVIEWING SEVERAL INDIVIDUALS NOW RESIDENT
GERMANY WHO MAY BE ABLE THROW LIGHT ON HEINE'S BONA FIDES. MORE
PARTICULARLY, ON THESIS HEINE RECRUITED BY RIS AT SOME TIME IN
CAREER, ACTED FOR THEM DURING PERIODS CONFINEMENT AND RELEASED
TO WEST AS RIS-DISPATCHED AGENT.

3. THREE INDIVIDUALS INVOLVED SERVED WITH HEINE IN SOVIET
PRISON CAMPS AND EVENTUALLY REPATRIATED TO GERMANY, TWO IN SAME
GROUP WITH HEINE, ONE SOME TIME PREVIOUS. INFORMATION ON THEM
SUPPLIED BY HEINE AS FOLLOWS -

BORN SOUTH AFRICA, ARRESTED CLOSE WAR IN POLAND,
SENTENCED 25 YEARS IN PRISON, SERVED WITH HEINE IN CAMP NEAR KAMA,
REPATRIATED OCT 56 IN SAME GROUP AS HEINE.

GERMAN FEDERAL REPUBLIC

SCHOOLBOY FRIEND OF HEINE IN TARTU, HEINE MET HIM
IN PRISON CAMP NEAR KAMA ABOUT 1951-52. BRETT WAS SENTENCED
TO 25 YEARS BUT WAS REPATRIATED TO GERMANY AS A RETURNED POW
SOME TIME PRIOR OCT 56.

4. IF ANY ONE OF THESE THREE HAS ANY INFO ON HEINE WHICH
SIGNIFICANTLY DIFFERS FROM OWN STORY OR WHICH SEEMS TO GIVE
CREDENCE HIS RIS AGENT STATUS, LAWYERS DESIRE HAVE FORMAL
DEPOSITION TAKEN FOR SUBSEQUENT USE AT TRIAL. HOWEVER, IF THEY
INITIATE ACTION TO INTERVIEW THESE PEOPLE THROUGH REGULAR LEGAL
CORRESPONDENT CHANNELS, COST, WHICH FYI IS BEING BORNE BY KUBARK,
WILL BE SUBSTANTIAL. THUS, WOULD APPRECIATE HAVING THEM INTER-
VIEWED UNOFFICIALLY BY CAVATA, WITH THE IMPORTANT STIPULATION THAT
THIS MUST BE DONE UNDER COVER ROUTINE SECURITY CHECK ON HEINE,
WITH ABSOLUTELY NO REFERENCE PENDING LITIGATION. IN EVENT ANY
OF THE THREE HAS USEFUL INFORMATION TO PRESENT, ATTORNEYS CAN
LATER ARRANGE DEPOSITION AT U.S. CONSULATE.

5. IN REQUESTING THIS SUPPORT FROM CAVATA MIGHT BE USEFUL
POINT OUT ANY THESE INDIVIDUALS WITH BALTIC BACKGROUND RELEASED
AS RETURNING GERMAN POWS MIGHT HAVE THEMSELVES BEEN CANDIDATES
FOR RIS RECRUITMENT, THUS THEIR OWN BONA FIDES MAY BE SUBJECT
QUESTION.
