1. HQS PUBLIC POSITION REMAINS THAT KUBARK "UNABLE TO COMMENT" BECAUSE CASE BEFORE COURT. IT CLEARLY RECOGNIZED THAT THIS LEGAL INABILITY COMMENT DOES NOT APPLY TO SMABOVES.
2. HOWEVER IT OF GREATEST IMPORTANCE TO US THAT THERE BE LEAST POSSIBLE KNOWLEDGEABLE COMMENT AT THIS TIME. IT FULLY APPRECIATED THAT CASE ARISES AT MOST INOPPORTUNE TIME FOR SMABOVES. NEVERTHELESS WE FORCED TO HOLD TO OUR POSITION (A) THAT SMABOVE NOT COMMENT ON KUBARK ORIGIN INFORMATION IF ANY POSSIBILITY EXISTS THAT COMMENTS WILL BECOME PUBLIC AND (B) THAT KUBARK SMABOVE COOPERATION ON ANY CASE MUST BE TREATED AS PRIVILEGED UNLESS BY PRIOR AGREEMENT.
3. IF SMABOVES ASKED BY GOVERNMENT TO COMMENT ON CHARGES MADE BY KUBARK, BELIEVE THEY SHOULD REPLY THAT THEY "NOT ABLE EVALUATE CHARGES DUE FACT THEY RELATE TO TIME PERIOD PRIOR TO SUBJECT'S ARRIVAL IN CANADA." REPLY TO PRESS INQUIRIES MUST BE "NO COMMENT." IF PRESS ASKS WRETHET KUBARK HAS PROVIDED TO SMABOVES BASIS FOR KUBARK CHARGES, REPLY MUST BE THAT ALL EXCHANGES ~~EXCHG~~ OF SECURITY INFORMATION BETWEEN GOVERNMENTS ARE PRIVILEGED COMMUNICATIONS AND SMABOVES THEREFORE NOT ABLE COMMENT IN THAT REGARD.

5. RE PARA 3 REF, THERE NO OBJECTION WHATEVER TO [] DISCUSSION PROBLEM IN DETAIL WITH SMABOVES. KUBARK POSITIONS OUTLINED PARAS 1, 2, 3, AND 4 ABOVE RELATE TO HANDLING OF MATTER BY SMABOVES WITH GOVERNMENT OFFICIALS WHERE POSSIBILITY EXISTS OF SUBSEQUENT LEAKS TO PRESS.
