Q: Were you one of five men left in your battalion when you were captured by the Russians in 1944?

A: Yes.

Q: Were you the only man left in your guerrilla band just before you were captured by the Russians in 1950?

A: Yes.

Q: How many months were you in Russian hands altogether?

A: 103--almost nine years.

Insert: How much of that period with a price on your head?

Q: You claim you were beaten and tortured. Do you know why the beatings stopped in 1953?

A: No.

1. Is it true that you served both in the Nazi SS and the SO, and if so, were you then working for the Nazis or the Soviets? *Try to give a good answer to this!!!*
2. Are you presently in contact with Soviet intelligence in the United States, or Canada? *He will say "No"; Headline "Accused Soviet agent denies links with Soviets"*
3. Were you personally acquainted with Arthur Hamann? Did you ever try to organize balloon operations into Estonia with Hamann and if so, what was their purpose? (mentioned in Washington Star story of April 20th.)
4. When you arrived in Germany from the USSR in late 1956 were you immediately interrogated by American authorities? How long did this interrogation last? *Oh, as the CIA did interrogate him!!!*
5. According to your own deposition, when you were captured by the Soviets after the Battle of Tartu in August 1944 you were wearing the uniform of a lieutenant in the Nazi SS. How were you lucky enough to avoid being shot? You testified that you told your captors you were an Estonian, not a German. Wouldn't they shoot you for that?
6. Several times in your deposition you testified that the Soviets knew you to be an Estonian and therefore a Soviet citizen. At about page 359 you stated that in December 1944 the Soviets declared you an enemy of the State because you were an Estonian in the Nazi Army and therefore a traitor. How do you explain your repatriation to Germany in 1956 as a German citizen?
7. Referring to the post World War II period when you state that you served with Estonian guerrillas in the forests, fighting the KGB, is it true that all your comrades were gradually killed off and you were lucky enough to be the only survivor? What were the circumstances of the death of the last man in December 1949, as described by you in your deposition?
