MEMORANDUM FOR THE RECORD

SUBJECT: HEINE's Visits to the United States

1. On 9 May 1966 [ ] called me to his office and asked me to check urgently for information pertaining to whether or not HEINE was physically visiting within the United States on the three occasions when RAUS made the statements specified in the complaint. The three occasions are as follows:

November 9, 1963 in New York City at a special meeting of the Board of the Legion of Estonian Liberation.

July 4, 1964 at an Estonian gathering at Laurel Acres, Pasadena, Maryland (near Baltimore) to Mr. Kuklane.

September 4, 1964 at an Estonian gathering at Estonian House, Baltimore, to Mr. Kuklane.

2. Our HEINE file reflects a visit by [ ] to the Immigration and Naturalization Service offices in Washington on 18 January 1965 in order to review the INS files on HEINE. His memorandum indicates that HEINE was in the United States during 1963 and 1964 as follows:

1963 --- May 3-15, announced designation for visa: Estonian House New York City. HEINE in fact lectured in the New York area (this from HEINE's itinerary as provided by RAUS from emigre sources).

1963 --- May 9-15 July, Estonian House, New York City. In fact HEINE continued his lecture tour and remained beyond the expiration date of his visa until 21 July 1963, appearing in various U.S. cities.


1963 --- November 30-December 1, Buffalo, New York

1964 --- April 3-8, to visit Mr. Elmarkeerd

3. I called Alien Affairs Branch in order to arrange contact with the appropriate officer in INS for the purpose of getting further information on HEINE's visits to the U.S. Alien Affairs Branch put me in touch immediately with Mr. Ralph Farb of INS, Telephone - Code 155, Extension 273. Farb told me that as soon as the HEINE case had reached the newspapers he had called for

HEINE's file and found that it had been retired to Archives. He had put in a request for recovery of the file but did not expect it for a day or two. Farb called me on 11 May 1966 to advise me that the file had been received but that it showed no further entries after the April 1964 visit. I told Farb that our information was that HEINE had become a Canadian citizen in August 1964, and I asked him whether his entries into the U.S. as a Canadian citizen would be reflected in any INS records. He told me that normally they would not be so reflected, so that it would be impossible to state for a certainty whether or not he had been in the U.S. after he had received Canadian citizenship.

4. From the above it would seem that on the first two occasions (9 November 1963 and 4 July 1964) HEINE was not physically in the U.S. The third occasion (4 September 1964) is still an open question. I have asked RAUS to check discreetly through one (only) of his Estonian friends to try to determine where HEINE was on the latter date. I emphasized to him that he must not spread this around in the emigre community or make a big issue of it.
