1. LATE SUMMER '55 <sup>ESTONIAN</sup> PARTISANS, IN COORDINATION TIEBARS VIA TWO W/T STATIONS ESTONIA, PLANNING EXFILTRATE COURIER TO SWEDEN FOR TRAINING AND RE-INFILTRATION ESTONIA. COURIER TO BE ACCOMPANIED BY ANOTHER ESTONIAN (WHO HAD BEEN IN SIBERIA) WHO GOING SWEDEN CLAIM INHERITANCE FAMILY INVESTMENTS TALLINN SHIPPING ASS'N. HIS BROTHER (ALSO AN HEIR) UTILIZED BY PARTISANS <sup>FOR</sup> INTERNAL SUPPORT THIS OP.

2. TIEBARS CANCELLED SUPPORT THIS OP USING PSEUDO OPERATIONAL PROBLEMS AS EXCUSE. DECISION BASED ON CONFESSION OBTAINED BY SMOTH EARLY FALL '55 <sup>FROM</sup> ANOTHER COURIER SENT OUT BY PARTISANS IN JUNE '55 TO OBTAIN BRITISH AND/OR AMERICAN SUPPORT FOR ORGANIZATION. COURIER CONFESSED HE SENT BY KGB WHO CONTROLLED THE INTERNAL ORGANIZATION.
