1. REF DATA MOST INTERESTING. FYI ONLY HEINE CLAIMS HE FIRST LEARNED MOTHERS WHEREABOUTS IN CANADA AFTER HIS REPATRIATION TO GERMANY (26 NOVEMBER 1956) BY WRITING TO ESTONIAN LEGATION LONDON. THEN CORRESPONDED WITH MOTHER, SHE SENT HIM HIS BIRTH CERTIFICATE AND 1941 REPATRIATION CERTIFICATE (ESTONIA TO GERMANY) WHICH HE NEEDED FOR GERMAN CITIZENSHIP APPLICATION. FILED APPLICATION OLDENBURG 15 DECEMBER 1956 USING THESE DOCUMENTS. HARDLY POSSIBLE FOR THIS CORRESPONDENCE ~~XX~~ EXCHANGE BE COMPLETED IN SHORT TIME PERIOD ABOVE, THEREFORE DATES HEINE'S FIRST CORRESPONDENCE WITH LEGATION IMPCRTANT.
