MEMORANDUM FOR: Deputy Assistant Secretary for Security

SUBJECT: Erik HEINE

1. Reference is made to your Visa Action Request for information dated 28 March 1967, carbon copy attached, on Erik HEINE, born 11 September 1919 in Estonia.

2. Erik HEINE is the plaintiff in the lawsuit HEINE v RAUS which developed from statements made by Juri RAUS, who was acting on the instructions of this Agency, that Erik HEINE was a KGB agent. RAUS, who defended himself on the grounds that he was acting under absolute privilege when he made the statements, received a favorable decision before the United States District Court for the District of Maryland on 8 December 1966. HEINE has appealed the decision and the case is now before the United States Court of Appeals for the Fourth District.

3. This Agency continues to regard HEINE as a dispatched KGB agent, but owing to the pending lawsuit we request that no action be taken to bar his entry into the United States without prior coordination with this Agency. Since HEINE is now a Canadian citizen we assume he no longer needs a visa to visit the United States, and we would therefore appreciate being advised of the reason for initiating the visa action request.




