1. SMABOVE REPORTS THAT HEINE CAME TO OTTAWA ON 17 OCTOBER WHEN THERE WERE DEMONSTRATIONS SCHEDULED, BUT HE DID NOT TAKE PART IN SAME AND HIS VIOLENT ACTS WERE ENTIRELY COMMITTED BY HIMSELF ALONE. AFTERNOON 17 OCTOBER HE THREW ROCKS AT SOVI CONSULATE AND BROKE

NEARLY ALL WINDOWS IN THE BUILDING ON THE TWO SIDES WHICH HE COULD REACH FROM STREET. AS THE BUILDING IS AN OLD STUCCO STRUCTURE, HE DID CONSIDERABLE DAMAGE TO STUCCO WHICH FELL OFF IN LARGE HUNKS. HE ALSO DID EXTENSIVE DAMAGE TO A SOVIET ZIM CAR PARKED ON STREET. ADDITIONALLY HE THREW SEVERAL RED PAINT BOMBS AT CONSULATE. TOTAL DAMAGE AND COST

OF CLEANUP ESTIMATED BY EXTAFF TO BE CIRCA \$5000, WHICH CANADIAN GOVT WILL HAVE TO PAY. SOVIETS HAVE, INCIDENTALLY, DEMANDED THIS REPARATION.

2. ODDLY ENOUGH, THIS ONE MAN GANG WAS NOT ARRESTED BY THE POLICE THE DAY OF HIS DESTRUCTIVE ACTS (HE HAD RETURNED TO TORONTO ON 17 OCTOBER) BUT ONLY LATER. HE REPORTEDLY CAME TO OTTAWA WITH THREE OTHER PERSONS BUT HIS ARREST WAS NOT CONNECTED WITH ANY OTHER PERSONS AND HE WAS CHARGED FOR HIS OWN INDIVIDUAL ACTS OF DESTRUCTION. HE WAS CHARGED ON 22 OCTOBER AND ARRESTED ON 24 OCTOBER, BEFORE THE KOSYGIN VISIT TO TORONTO. HE WAS HELD, BROUGHT TO OTTAWA ON 25 OCTOBER AND CHARGED IN COURT ON 26 OCTOBER. HE WAS SUBSEQUENTLY REMANDED ^{EP} UNTIL THE TIME OF HIS TRIAL, SET FOR 10 DECEMBER.

3. HEINE TOLD HIS LAWYER THAT HIS ARREST AND BEING HELD WITHOUT BAIL FOR SEVERAL DAYS WAS A JKLANCE PLOT. HOWEVER, THE SMABLE OFFICER WHO TALKED WITH THE LAWYER EXPLAINED ABOUT HEINE'S FIXATION WITH JKLANCE AND IT APPEARS THE ^{LA} ~~OR~~ WYER DOES NOT BELIEVE HEINE'S CLAIM. THERE IS GOOD REASON TO BELIEVE THAT HIS LAWYER MAY ATTEMPT TO DISCOURAGE HEINE FROM MAKING SUCH ALLEGATIONS AT HIS TRIAL, BUT WITH HEINE ANYTHING IS POSSIBLE. WILL
