Contact Report - 29/30 August Meeting with General HEUSINGER

Reference - EGIA-5241

1. Upon the HEUSINGERS' return from Austria, they were houseguests of the undersigned for several days. Among other social activities, we included a dinner with the [ ] and [ ]. This was the first opportunity Wallop has had to converse with HEUSINGER since the latter's state-side visit.
2. In an atmosphere of congeniality, HEUSINGER recounted his reflections of the trip to the United States for the benefit of [ ]. HEUSINGER stated he and BLANK were most impressed with their journey and considered it a very beneficial experience toward their defense planning activities. They were particularly pleased and grateful for the wonderful reception accorded them throughout their tour.
3. As pertains to the KUBARK interest of their trip, nothing startlingly new was mentioned (see reference). HEUSINGER was particularly impressed with the professional competence and intimate knowledge Asaban, Knight and [ ] professed on the ZIPPER complex.
4. [ ] mentioned some of the recent difficulties encountered with UTILITY, particularly the demands to abolish the opposite member system and reduction of the FGB staff. Contrary to UTILITY's oft-repeated statement that the major deterrent to the future legalization of URSWING will be the American label and the influence the U.S. has exerted on the ZIPPER organization, HEUSINGER reflected that at no time has he ever heard any objection to ZIPPER's legalization in respect to the American influence, etc. To the contrary, American involvement is considered a natural and accepted event in view of the subsidy of ZIPPER and, in general, due to the major role the U.S. plays in European foreign policy. HEUSINGER opines that UTILITY's main aim in eliminating the opposite member system and reduction of the FGB staff is based on UTILITY's strong desire to eliminate KUBARK operational insight to his modus operandi and intelligence personalities. This has been bothering UTILITY for a long time - not so much in the evaluation and

reports field (since little insight of the ZIPPER activities can be observed there) as in the collection, CI/CE and other operational elements of ZIPPER.

5. Pertaining to UTILITY and ZIPPER's internal political meddling, HEUSINGER named Franz Josef STRAUSS, head of the German Committee for EDC, MELLIES and EHLER of the SPD as three gentlemen who have levelled the charge. HEUSINGER does not think they have any specific acts to cite but rather were expressing a general fear based on what they have heard of the many ZIPPER domestic informants in the so-called "Special Connection" activities. HEUSINGER thinks the best manner to eliminate much of the fear and suspicion is for UTILITY to renew and establish closer contact with OLLENHAUER and the SPD where the rumor of ZIPPER's internal machinations seems to be the most prevalent. In contrast to HEUSINGER's statements to Wetmore concerning his personal opinion of 35 activities, he gave the impression of no personal objections to the activities in this field and indicated an objective need and necessity for the 35 shop.

6. On 29 August HEUSINGER had a two-hour conference with UTILITY during which time there reportedly was a detailed discussion of present problems and an exchange of views regarding the future. HEUSINGER stated he found UTILITY in good spirits, relatively optimistic and objective. Allegedly, UTILITY did not belabor the opposite number system with HEUSINGER except to state that a solution to the future relationship must be found. Apparently UTILITY is finding it increasingly difficult to maintain a delicate balance, serving and satisfying both KUBARK and the ever-increasing demands of UPGROWTH.

7. Other points related by HEUSINGER:

- (a) UTILITY will see OLLENHAUER and others of the SPD in the near future with the hope of getting a reconfirmation of top SPD support.
- (b) On or about 15 September UTILITY will visit UPTHRUST and discuss with him the problems of his organization and attempt to find a solution to the relationship of ZIPPER with UPGROWTH.
- (c) Discussion about the possibility of legalization of UFSWING without waiting for the ratification of the treaties. UTILITY and HEUSINGER are of the opinion that the legalization of UFSWING can come about in the near future if the U.S. is in favor of this move and is prepared to exert some political pressure on the British and the French.
- (d) Some discussion on the future of KUBARK liaison; however, HEUSINGER did not go into details except to say that it is his understanding that there will be liaison in Munich (covert) and in Bonn (overt).
