Full Operational Clearance is requested on Subject. Following paragraphs are keyed to the PRQ Part II form.

- 36. CARGER-1
- 37. Subject was never contacted by KUBARK. Agent status commenced on 21 March 1954 when KUBARK assumed financial responsibility by reimbursing HICOG for agent's pay.
- 38. Yes. Subject would not know about change.
- 39. Subject gets satisfaction from performing chosen profession. Financial motivation present since HICOG pays his only source of income.
- 40. COM, CIC, POB and Headquarters. Positive traces did not develop derogatory information.
- 41. His present pay is his only source of income. Some control exists inasmuch as he likes his job, being his chosen occupation. Prestige is attached through his position with HICOG.
- 42. Strictly for HICOG. He knows that the information is being given distribution to several U.S. offices in Berlin.
- 43. HICOG personnel files do not indicate connection with other intelligence services.
- 44. Police Record Checks, Labor Office Record Checks, Neighborhood Investigations, Background Investigations. Above types are right in his field of experience. Most satisfactory.
