 2. SIX JOINED THE NSDAP IN JANUARY 1923 AND ACCORDING TO

 PROHIBITION ON JANUARY 1, 1927. WITHIN THE NSDAP HE HELD  
 THE POST OF ORTSGRUPPENLEITER AT DACHAU. HE WAS AWARDED  
 THE FOLLOWING DECORATIONS: COBURG BADGE, GOLDEN PARTY  
 BADGE, BLOOD ORDER. THOSE WERE AWARDED BY THE NSDAP TO  
 ALL WHO PARTICIPATED IN THE MUNICH REVOLT ON NOVEMBER 9,

3. HE WAS A MEMBER OF THE STURMABTEILUNG (SA) FROM OCTOBER 1, 1922 ON AND AGAIN FROM JANUARY 1, 1927 TO JULY 1929. HE BELONGED TO THE DEUTSCH-VOLKISCHE SCHUTZ-UND TRUTZBUND (PARA MILITARY ORGANIZATION). FROM APRIL 10, 1933 TO JUNE 10, 1933 HE PARTICIPATED IN AN INSTRUCTION COURSE FOR AUXILIARY POLICE SERVICE HELD BY THE STATE POLICE IN MUNICH. HE JOINED THE GENERAL SS ON JULY 15, 1929 AND INITIALLY ASSIGNED TO SS-STURM 1/I/1 AS AN SS TRUPPFUEHRER (SGT). IN 1932/33 HE SERVED IN THE 2D ESCORT DETACHMENT OF ADOLF HITLER (2 BEGLEITKOMMANDO DES FUEHRER).

4. AS OF APRIL 10, 1933 HE SERVED IN THE SS GENERAL SERVICE TROOPS (LATER TO BECOME THE WAFFEN SS) AS AN SS STURMBANNFUEHRER (MAJOR). HE SERVED WITH THE FOLLOWING UNITS: 1ST POLITICAL SERVICE TROOPS, MUNICH, FROM APRIL 4, 1933; 1ST SS REGIMENT "DEUTSCHLAND", UNTIL SEPTEMBER 1, 1936; SS REGIMENT "NUREMBERG", FROM SEPTEMBER 1, 1936, IN THE POSITION OF ADMINISTRATIVE OFFICER; STAFF OF THE 1ST SS REGIMENT "DEUTSCHLAND, REPLACEMENT OFFICE III, MUNICH, FROM JUNE 15, 1939; SS GENERAL KOMMANDO/SS CORPS GENERAL STAFF, FROM JUNE 20, 1942 AS A SUPPLY OFFICER; SUPPLY DETACHMENT/SS DIVISION "DAS REICH", FROM SEPTEMBER 1, 1942.

5. SIX SIGNED ON FOR SERVICE IN THE SS GENERAL SERVICE TROOPS UNTIL AGE 45 (OR JULY 7, 1951). COPY OF CONTRACT DATED NOVEMBER 11, 1934 IS INCLUDED IN HIS FILE. LEDSKY
