3. APPLICANT APPLIED FOR A B-2 VISA TO ENABLE HIM TO TAKE
A BUS TRIP BEGINNING SEPTEMBER 29 FROM TORONTO TO NIAGARA
TO PHILADELPHIA TO NEW YORK TO WASHINGTON TO TORONTO.
HE PLANNED TO PARTICIPATE IN A PARADE IN PHILADELPHIA
COMMEMORATING IMMIGRATION FROM KREFELD, GERMANY TO THE
U.S. HE IS SCHEDULED TO LEAVE GERMANY FOR CANADA ON SEP-
TEMBER 26.
4. APPLICANT STATED HE CAME FROM ROMANIA IN 1932 TO
ATTEND THE UNIVERSITY OF ERLANGEN. HE JOINED THE
ALLGEMEINE SS NOVEMBER 15, 1932 AND THE NSDAP IN MAY 1933.

HE FINISHED HIS STUDIES AT ERLANGEN IN MARCH 1935.

5. APRIL 1935 TO MARCH 1936, HE ATTENDED KONIGSBERG UNIVERSITY. MARCH 1936 TO DECEMBER 1938, HE ATTENDED THE UNIVERSITY OF BERLIN. FROM JANUARY TO AUGUST 1939; HE WAS A DOCTOR AT THE CHARITE CLINIC IN BERLIN.

6. ON SEPTEMBER 18, 1939, HE JOINED THE ARMED SS. FROM SEPTEMBER TO NOVEMBER 1939, HE WENT FOR TRAINING IN BERLIN WITH THE LICHTERFELDE ERSATZ BATTALION.

7. FROM NOVEMBER 1939 TO APRIL 1940, HE WAS IN PRAGUE WITH THE SANITAETS ERSATZ BATTALION, THE CHIEF BEING A DR. ROETTGER.

8. FROM MAY 1940 TO NOVEMBER 1943, HE WAS WITH THE THIRD PANZER DIVISION OF THE ARMED SS, WORKING AS A DOCTOR UNDER DR. FEHRENSSEN. FROM MAY 1940 TO MAY 1941, HE WAS AT THE TRUPPENEUBUNGSPLATZ, CHALON-SUR-MARNE, FRANCE; JUNE 1941 TO MAY OR JUNE 1943, IN STARADA ROESSA, USSR; THEN IN RETREAT THROUGH THE UKRAINE.

9. DURING THE AUTUMN OF 1943, HE SAID HE WAS ON LEAVE IN GERMANY, THEN WAS ASSIGNED AS HEALTH OFFICER TO THE WAR SCHOOL AT KLAGENFURT, AUSTRIA, FROM JANUARY 1944 TO MAY 1945, WHERE HE WAS TAKEN PRISONER BY BRITISH FORCES.

10. HE STATED HE ALWAYS WORKED AS A TROOP DOCTOR. HE STATED HE WAS AN SS OBERSCHARFUHRER FROM JULY 1937 TO AUGUST 1939. IN 1940, HE SAID, HE WAS AN UNTERARZT WHICH GAVE HIM A RANK EQUIVALENT TO UNTERSTURMFUEHRER; 1942 OBERARZT, EQUIVALENT TO OBERSTURMFUEHRER; 1943 STABSARZT, EQUIVALENT TO HAUPTSTURMFUEHRER. THE BDC LISTED HIM AS 2ND LIEUTENANT IN RESERVE APRIL 20, 1949 (SIC - PRESUMABLY 1939 WAS MEANT); THEN 1ST LT IN RESERVE 1942 AND CAPTAIN IN RESERVE, 1943, THE FIRST DATE BEING AT VARIANCE WITH THE INFORMATION HE PROVIDED.

11. HE WAS RELUCTANT TO GIVE EXACT UNIT NAMES, SAYING HE WAS ALWAYS IN THE MEDICAL UNIT, ALTHOUGH LATER IN THE INTERVIEW HE SAID HE WAS IN THE DEATH'S HEAD DIVISION. THE BDC LIST WAS LEIBSTANDARTE SS "ADOLF HITLER" (SEPTEMBER 1939-); 3RD MEDICAL REPLACEMENT COMPANY, PRAGUE (NOVEMBER 1939-); SS DEATH'S HEAD DIVISION (JANUARY 30, 1942-); SS OFFICER CANDIDATE SCHOOL KLAGENFURT.

12. HE STATED HE WAS AWARDED A FIRST IRON CROSS IN 1942 AND IS A HOLDER OF THE SS DEATH'S HEAD RING AND SABER WHICH HE SAID HE RECEIVED WHEN HE WAS PROMOTED TO CAPTAIN.

13. HE DENIED ANY MEMBERSHIPS IN ROMANIA BEFORE COMING TO GERMANY, OTHER THAN THE WANDERVOGEL, BUT THE BDC REPORT STATES HE WAS ACTIVE IN THE GERMAN YOUTH IN TRANSYLVANIA NATIONAL SOCIALIST LEAGUE AND LEADER OF THE UNION OF ABROAD LIVING ETHNIC GERMANS.

14. HE PRESENTED A DENAZIFICATIO CERTIFICAT IN A SOMEWHAT DIFFERENT FORM FROM THAT WHICH CONOFFS ARE ACCUSTOMED TO SEEING. IT IS ABOUT FIVE INCHES HEADED ENTLASTUNGSZEUGNIS (CLEARANCE CERTIFICATE) WITH THE NOTATION ARN/HM/961/G 34/35, AND STATES APPLICANT "HAS BEEN CLEARED UNDER THE PROVISIONS OF MILITARY GOVERNMENT ORDINANCE NO. 79". IT IS DATED JULY 28, 1949, AT HAMM

UNCLASSIFIED

(WESTF.). IT DOES NOT SHOW A DENAZIFICATION CATEGORY, BUT CONOFF HAS NO REASON TO DOUBT ITS AUTHENTICITY.

15. UNLESS DEPARTMENT HAS ADDITIONAL INCRIMINATING INFORMATION, A FAVORABLE DECISION IS RECOMMENDED.

16. APPLICANT FIRST SENT HIS PASSPORT TO DUESSELDORF WHERE CONSULAR SERVICES ARE NO LONGER AVAILABLE. WHEN HIS APPLICATION WAS FINALLY RECEIVED HERE, HE WAS APPARENTLY NOT INVITED TO APPEAR PERSONALLY THROUGH AN OVERSIGHT. SINCE HIS TRAVEL IS PLANNED FOR SEPTEMBER 26, AN EARLY REPLY IS URGENTLY REQUESTED. WOESSNER
