2. SUBJECT WAS INTERVIEWED CONCERNING HIS ACTIVITIES

DURING THE PERIOD 1933-45. ON MAR 19, 1984

HIS ANSWERS CORRESPONDED CLOSELY WITH THE

INFORMATION CONTAINED IN REFTEL. HE CLAIMED THAT

HE SERVED WITH THE GERMANIA REGIMENT FROM 1935

TO 1941 AND THEN WITH THE OFFICE OF SS COMMANDANT

HAMBURG AND ADMINISTRATION UNIT UNTIL 1942. AT THAT

TIME HE WAS TRANSFERRED TO THE ADMINISTRATIVE SECTION

OF THE SS DIVISION LEIBSTANDARTE ADOLF HITLER, WHERE

HE SERVED UNTIL THE END OF WAR. HE WAS ADMINISTRATIVE

3. AT THE END OF WAR THE DIVISION BROKE UP ON THE PLATENSEE AND HE MADE HIS WAY ON FOOT TO HAMBURG WHERE HE TURNED HIMSELF IN TO THE BRITISH AUTHORITIES. HE WAS HELD FOR TWO YEARS AND RELEASED WITH A DENAZIFICATION CATEGORY OF IV OR FOLLOWER

4. HE DENIES HAVING HAD ANYTHING TO DO WITH ANYTHING WHICH COULD BE CONSIDERED WAR CRIMES. BASED ON THE INFORMATION CONTAINED REFTEL HIS STATEMENTS AND HIS RELEASE AND DENAZIFICATION DOCUMENTS POST RECOMMENDS BARRING ANY INFORMATION AVAILABLE TO THE DEPARTMENT AND NOT TO POST THAT HIS NAME BE STRICKEN AND THE REQUESTED VISA BE ISSUED.

5. HE HAS BOOKED AND PAID FOR CHARTER FLIGHT ON APR 13 1984 POST WOULD APPRECIATE YOUR ASSISTANCE IN OBTAINING A PROMPT REPLY
