MR. PENDZICH HAS SUBMITTED AN ADDITIONAL, SHORT SIGNED STATEMENT ABOUT HIS THREE MONTH ASSIGNMENT TO THE WAFFEN SS. HE DOES NOT REMEMBER ANY PARTICULAR UNIT ASSIGNMENTS, EXCEPT THAT HE WAS IN THE LEIBSTANDARTEN ADOLF HITLER, BECAUSE HE WAS IN THE RESERVE ONLY AND WAS NEVER ASSIGNED TO ANY PARTICULAR UNIT AND NEVER HELD PARTICULAR RESPONSIBILITY FOR ANYTHING. THE ONLY COMMANDERS NAME HE KNOWS IS THAT OF GENERAL SEPP DIETRICH. HE WAS STATIONED IN LUEBBEKE WESTFALEN DURING DECEMBER 1944 AND WAS TRANSFERRED TO DAUN IN THE EIFEL IN JANUARY 1945. HIS FIRST ASSIGNMENT OUT OF THE SS RESERVES WAS IN FEBRUARY 1945, WHEN HE WAS SENT INTO COMBAT IN HUNGARY AND WAS SUBSEQUENTLY WOUNDED ON MARCH 6TH, 1945. HE CLAIMS NO COMBAT ACTIVITY EXCEPT FOR THE FEW WEEKS IN FEBRUARY AND MARCH 1945 IN HUNGARY.
