THAT ZUBER WAS INDEED COMMANDER OF THE STAFF COMPANY.

2. KRANKENBUCHLAGER RECORDS INDICATE THAT ZUBER WAS WOUNDED BY A HAND GRENADE SPLINTER ON HIS RIGHT THIGH AND SHANK AS A RESULT OF AN ACCIDENT IN A TRAINING AREA. NO DETAILS ARE PROVIDED AS HOSPITALIZATION OR MEDICAL CARE FOR THAT INCIDENT; HOWEVER, RECORDS SHOW THAT, BASED ON

THREE REPORTS FROM APRIL 1944, HE WAS ASSIGNED TO SS-HAUPTAMT, GRUPPE D, HAUS GERMANIA (SS CENTRAL DEPARTMENT, OFFICE D, GERMANIC OFFICE), PROBABLY THROUGHOUT 1944. UNTIL APRIL 16, 1944 KRANKENBUCHLAGER RECORDS HAVE HIM AT THE SS LAZARETTABTEILUNG (SS HOSPITAL TRANNSTEIN) AND FROM APRIL 16, 1944 AT RESERVE LAZARETT (RESERVE HOSPITAL BAD TOELZ) AND ON SEPTEMBER 19, 1944 RELEASED FROM THE HOSPITAL TO RETURN TO ACTIVE SERVICE.
