1. VISAS TWO WILHELM HERMANN EDMUND BOLZE (33).
2. MR. BOLZE WAS A MEMBER OF THE ALLGEMEINE - SS DURING THE PERIOD IN WHICH IT WAS ENGAGED IN THE TERRORIZING OF JEWS AND OPPOSITION MEMBERS, AND IN THE GUARDING AND MANAGEMENT OF THE BURGEONING CONCENTRATION CAMP SYSTEM. HE MAY WELL HAVE PLAYED A ROLE IN THE ROEHM PURGE AS A MEMBER OF THE SS - VERFUEGUNGSTRUPPE.
3. MR. BOLZE ALSO SERVED WITH THE LEIBSTANDARTE ADOLF HITLER IN THE ROSTOV AREA OF RUSSIA DURING A TIME WHEN THAT UNIT MASSACRED THOUSANDS OF RUSSIAN CIVILIANS AND PRISONERS OF WAR, AND ACTIVELY ASSISTED EINSATZGRUPPEN IN THE EXTERMINATION OF JEWS AND SOVIET OFFICIALS.
4. THERE ARE SEVERAL REASONS TO ASSUME MR. BOLZE'S VERACITY TO HAVE BEEN IMPEACHED. HE HAS DENIED MEMBERSHIP IN THE NAZI PARTY, YET BDC FILES CONTAIN HIS SOLDIERS PAY BOOK, LISTING HIM AS PARTY MEMBER 3,126,718

AS OF MAY 1, 1933. HE HAS ALSO STATED THAT HE WAS NEVER PROMOTED TO SS - OBERSCHARFUEHRER, STRANGELY ENOUGH. YET IN TWO DOCUMENTS, A FAMILY HISTORY DECLARATION TO THE RASSE AND SIEDLUNGS HAUPTAMT APPARENTLY IN HIS OWN HANDWRITING, AND HIS SOLDIER'S PAY BOOK, HE IS DESCRIBED AS SS - OBERSCHARFUEHRER.

5. IN ADDITION TO THE ABOVE MISREPRESENTATIONS, HE MAINTAINS THAT HE WAS NEVER DENAZIFIED BECAUSE HE WAS A "PRIVATE WAFFEN - SS SOLDIER". NOT ONLY WERE SOME PRIVATE SOLDIERS IN THE WAFFEN SS DENAZIFIED, BUT MANY OF THE NONCOMS WERE AS WELL. THERE IS ALSO THE QUESTION OF THE VERY LARGE FINE PAID UPON HIS RELEASE, 900 RM, WHICH IS MORE THAN MANY SS OFFICERS WERE FINED.

6. BASED UPON HIS MEMBERSHIP IN THE ALLGEMEINE AND WAFFEN - SS, IN THE ABSENCE OF ANY EXCULPATORY EVIDENCE, AND GIVEN THE UNTRUSTWORTHY NATURE OF HIS TESTIMONY, DEPARTMENT CONCLUDES THAT MR. BOLZE IS INELIGIBLE UNDER 212(A)(33). HIS NAME WILL BE ENTERED AS 33 IN AVLOS. WHITEHEAD
