SUMMARY: TO PROVIDE DEPARTMENT WITH BDC SUMMARY ON SS OBERFUEHRER ELLERSIECK, FIRST NAME UNKNOWN, DPOB UNKNOWN TO DETERMINE CONNECTION BETWEEN ELLERSIECK, MANNSCHAFTHAUESER AND THE SD; TO PROVIDE INFORMATION ON A FRITZ ULRICH, PREVIOUSLY FURNISHED, TO DETERMINE WHETHER HE IS THE SAME INDIVIDUAL THAT APPEARS IN A JANUARY 1945 TABLE OF ORGANIZATION FOR RSHA AMT 6, DESCRIBED AS HEAD OF AMT W13, AMTSGRUPPE WI/T (RECRUITMENT); TO DETERMINE THE POSSIBLE CONNECTION OF HERMANN ROEPKE, DPOB 14 MAY 1916, SUMMARY PREVIOUSLY FURNISHED, WITH THE SS-HAUPTAMT. BECAUSE OF THE COMPLEXITIES AND RESEARCH REQUIRED IN THOSE THREE CASES, BDC AND MISSION APOLOGIZE FOR DELAY IN REPLYING TO REFTEL. END SUMMARY.

-- HEINRICH HIMMLER ORDERED ELLERSIEK TRANSFERRED TO THE FIELD HEADQUARTERS OF THE REICH LEADER SS TO ORGANIZE THE "VOLKSSTURM" (FINAL RESERVE MOBILIZATION OF THE GERMAN PEOPLE);. THERE IS NO FURTHER INFORMATION AVAILABLE ON ELLERSIEK.

3. CAPTAIN ULRICH (RSHA, AMT 6, JANUARY 1945) IS NOT IDENTICAL WITH FRITZ ULRICH (JUNE 19, 1916). THIS IS BASED ON THE FACT THAT FRITZ ULRICH WAS MAJOR IN 1944 AND THE OTHER ULRICH WAS A CAPTAIN IN 1945. THERE ARE NO PROMOTION OR DEMOTION ORDERS IN EITHER FILE COVERING THAT PERIOD OF TIME AND THE SS, WITH THEIR PENCHANT FOR ACCURATE RECORD KEEPING WOULD HAVE CERTAINLY INDICATED SUCH A MAJOR PERSONNEL ACTION CONCERNING AN OFFICER.

4. FOLLOWING IS INFORMATION OUTLINING HERMANN ROEPKE'S CONNECTION WITH THE SS-HAUPTAMT AND THE BRITISCHER FREIKORPS:

MARCH 17, 1943-NOVEMBER 5, 1944:

-- ASSIGNED TO THE SS-HAUPTAMT, DURING SEPTEMBER AND NOVEMBER WAS ATTACHED TO AMTSGRUPPE D (GERMANISCHE LEITSTELLE), WHICH WAS THE DIRECTORATE FOR GERMANIC AFFAIRS, SPECIAL AFFAIRS, WHICH AMONG OTHER THINGS, WAS RESPONSIBLE FOR WAFFEN-SS RECRUITMENT OF ETHNIC GERMANS IN THE SOUTH EAST; HE LATER TRANSFERRED TO AMT A III (VERWALTUNG);

-- A REPORT FROM AMTSGRUPPE D TO HIMMLER DISCUSSES THE FORMATION AND DEVELOPMENT OF A BRITISCHEN FREIKORPS

CONSISTING OF FIFTEEN PEOPLE. THE REPORT WAS SIGNED BY THE CHIEF OF AMTSGRUPPE D, BERGER;

AUGUST 2, 1944:

-- BERGER PROPOSES COMMITTING TO THE FRONT FOR ACTION

TWENTY BRITISH INDIVIDUALS AND THAT ROEPKE SHOULD BE DESIGNATED THEIR LEADER BECAUSE OF PAST INVOLVEMENT IN THE

UNCLASSIFIED

PROGRAM;

NOVEMBER 18, 1944:

-- A LETTER FROM SS-STANDARTENFUEHRER SPARMANN REQUESTED AN ENGLISH SPEAKING SS LEADER FOR THE FORMATION OF THE BRITISCHER FREIKORPS. THE LETTER INDICATES THAT ROEPKE WHO HAD PREVIOUSLY BEEN DESIGNATED FOR THE POSITION WAS TRANSFERRED TO THE SS-FUEHRUNGSHAUPTAMT (SS OPERATIONAL HEADQUARTERS) BY THE SS MAIN OFFICE. SPARMANN IS DESIGNATED AS STABSFUEHRER IN DER AMTSGRUPPE D. THERE IS NO FURTHER INFORMATION ON ROEPKE'S CONNECTION WITH THE SS-HAUPTAMT.

5. FOLLOWING IS INFORMATION CONCERNING THE ESTABLISHMENT AND DEVELOPMENT OF THE SS-MANNSCHAFTSHAUESER:

1934:

-- THE FIRST ORGANIZATION WAS ESTABLISHED AND HAD BRANCHE IN CITIES HAVING MAJOR UNIVERSITIES;

NOVEMBER 1935:

-- THE SSM WAS PLACED UNDER THE AUTHORITY OF THE RACE AND SETTLEMENT OFFICE, THE RASSEREFERENTEN WAS RESPONSIBLE FOR THE ORDERLY PERFORMANCE OF THIS OFFICE AND TO INSURE THE INTEGRATION OF THE MEMBERS INTO THE RACE AND SETTLEMENT OFFICE, MEANING THAT THEIR RACIAL PURITY HAD TO BE VERIFIED;

1936/37:

-- RESPONSIBILITY FOR THE SSM WAS TRANSFERRED FOR SUPERVISION TO THE SCHULUNGS AMT (IDEOLOGICAL TRAINING OFFICE) DECEMBER 1937:

-- THERE EXISTED TEN SSM THROUGHOUT THE REICH; THE REICHSSTUDENTENFUEHRER ISSUED A PROCLAMATION THAT THE SSM WERE POLITICALLY AWARE PICKED TROOPS SELECTED ACCORDING TO SS PRINCIPLES AND ACTIVITIES WITHIN THE NS-DEUTSCHE STUDENTENBUND. HE FURTHER STATED THAT THE ONLY DIFFERENCE BETWEEN THE KAMERADSCHAFTEN DES NSDS AND THE SSM WAS THAT THE LATTER CONSISTED OF STUDENTS WHO WERE MEMBERS OF THE SS;

FEBRUARY 12, 1939:

-- THE SSM WAS PLACED UNDER THE JURISDICTION OF THE PERSONAL STAFF OF THE REICH LEADER OF THE SS IN ACCORDANCE WITH AN ORDER ISSUED BY HEINRICH HIMMLER. AT THIS TIME THERE WERE SIXTEEN SSM IN EXISTENCE AND ONE OF THE REASONS FOR THE ORGANIZATION WAS TO DEVELOP THE CURRENTLY NON-EXISTING SCIENTIFICALLY TRAINED GENERATION REQUIRED BY THE SS;

JUNE 1939:

-- A TOTAL OF TWENTY THREE SSM WERE IN EXISTENCE;

FEBRUARY 8, 1941:

-- SSM ORGANIZATION WAS OFFICIALLY DESIGNATED AMT IV (SS MANSCHAFTSHAUESER), AN ELEMENT OF HAUPTAMT DIENSTSTEL SS-OBERGRUPPENFUEHRER HEISSMEYER;

MARCH 1941:

-- GENERAL HEISSMEYER DIRECTED THAT THE CHEF DES AMTES IV, KOMMANDEUR DER SS-MANNSCHAFTSHAUESER, ELLERSIEK, WAS TO INSURE AND INSTILL CONFIDENCE IN THE PROGRAM

AND PROVIDE FUEHRERNACHWUCH FOR THE SS (FUTURE SSM APPLICANTS); ELLERSIEK SUCCEEDED IN BRINGING UP AN INTELLECTUAL TYPE OF LEADER WHO PROVED FIT FOR DUTIES ABROAD IN THE FOREIGN SERVICE OR THE REICHSSICHERHEITSHAUPTAMT;

MARCH 6, 1942:

-- SS-GRUPPENFUEHRER BERGER, CHIEF OF THE SS-HAUPTAMT REPORTED TO THE REICH LEADER OF THE SS, HIMMLER, THAT SS-OBERGRUPPENFUEHRER REINHARD HEYDRICH, CHIEF OF THE REICHSSICHERHEITSHAUPTAMT INFORMED HIM THAT THE ORDER BY THE REICHSFUEHRER SS NOT TO PUBLISH THE AGREEMENT MADE ON THE COLLABORATION OF THE RSHA AND THE SS-HAUPTAMT IN GERMANIC COUNTRIES IN THAT FORM. AT THE SAME TIME HE ASKED HIM TO ISSUE AN APPROPRIATE ORDER FOR THE HIGHER SS AND POLICE OFFICERS;

JUNE 4, 1942:

-- SS-GRUPPENFUEHRER BERGER INFORMED THE HIGHER SS AND POLICE OFFICER "NORTH WEST" IN THE HAGUE THAT, ACCORDING TO AN ORDER OF THE REICHSFUEHRER, HE HAD COME TO AGREEMENTS WITH SEVERAL NATIONAL SOCIALIST ORGANIZATIONS, AMONG THEM THE SS-MANNSCHAFTSHAUESER. IN THE FUTURE THE UNCLAS SECTION 04 OF 04 USBERLIN 03997

SUBJECT: REQUEST FOR BDC SUMMARY

GERMANISCHE LEITSTELLE WILL BE THE CENTRAL OFFICE FOR THE GERMANISCHE ARBEIT OF THE PARTY AND ITS AFFILIATED ORGANIZATIONS. INSTRUCTION WILL BE GIVEN BY THE GERMANISCH LEITSTELLE IN COORDINATION WITH THE RSHA. THE DETAILS OF THIS ARRANGEMENT COULD NOT BECOME IMMEDIATELY EFFECTIVE BECAUSE OF THE DIFFERENT SITUATION OF THE INDIVIDUAL COUNTRIES. SO FAR ONLY TWO COUNTRIES HAD HIGHER SS AND POLICE OFFICERS AS DEPUTIES FOR THE REICHSFUEHRER SS WHO COULD DEAL WITH THESE QUESTIONS.

AUGUST 31, 1942:

-- IN REPLY TO A REQUEST OF SS-STANDARTENFUEHRER SCHELLENBERG, RSHA, THE PERSONAL STAFF OF THE REICH LEADER SS EXPLAINED THAT IT WAS NOT POSSIBLE TO ASSIGN MEMBERS OF THE SSM TO THE REICHSSICHERHEITSAMT BECAUSE MOST OF THEM SERVED IN THE GERMAN ARMED FORCES (WEHRMACHT) AT THIS TIME.

MAY 20,

SS-GRUPPENFUEHRER VON HERFF, MAIN OFFICE, EMPHASIZED THAT ELLERSIEK HAD ALWAYS BEEN EXTREMELY CONCERNED WITH THE GERMANIC QUESTION IN CLOSE CONNECTION WITH THE SS-HAUPTAMT. ALMOST ALL MEMBERS OF H OFFICER CORPS WERE CONCERNED WITH THE SAME SUBJECT EITHER IN THE SS MAIN OFFICE OR THE GERMANISCHE KORPS WHICH WAS A UNIT OF THE WAFFEN SS. AMONG OTHER TASKS, THE GERMANISCHE LEITSTELLE BUILT UP THE SSM IN COUNTRIES HAVING A

HEAVY POPULATION OF ETHNIC GERMANS.

6. THE ABOVE INFORMATION WAS GATHERED FROM VARIOUS AND DIFFERENT COLLECTIONS WITHIN THE BDC AND CONSOLIDATED AS BEST AS POSSIBLE TO GIVE AS COMPLETE AND REASONABLE PICTURE OF THE QUESTIONS/ORGANIZATIONS REQUESTED. HOPE IT FITS THE BILL. WILLIAMS
