BELOW TWO LISTS OF DOCUMENTS INCLUDED IN MOHAWK  
ARMS' OFFERINGS FOR ITS APRIL 16 AUCTION. THE FIRST  
LIST OF 6 DOCUMENTS, IN PARA 4, HAVE BEEN DEFINITELY  
IDENTIFIED AS BDC DOCUMENTS AFTER A REVIEW OF BDC  
MICROFILMS OF THE CENTER'S HOLDINGS. THE SECOND  
LIST OF 43 DOCUMENTS, IN PARA 5, ARE STRONGLY

SUSPECTED OF BEING BDC DOCUMENTS. THE INFORMATION PROVIDED IN THE AUCTION CATALOGUE OMITTS DATES OR OTHER KEY INFORMATION THAT WOULD CONFIRM BDC OWNERSHIP, BUT BDC DIRECTOR BELIEVES HE COULD DETERMINE BDC OWNERSHIP UPON EXAMINATION OF THE DOCUMENTS.

2. ACTION REQUESTED. BERLIN PROSECUTORS HAVE JUST ARRESTED AND BROUGHT TO BERLIN A HAMBURG AUCTIONEER, ANDRE HUESKEN, AND ARE PROGRESSING RAPIDLY IN THE CASE. HOWEVER, THEY STILL LACK CRITICAL EVIDENCE CONCERNING KEY MIDDLEMEN WHO MAY WELL BE THOSE MOST RESPONSIBLE FOR ORGANIZING THE BDC THEFTS. THEREFORE, WHILE MISSION OBVIOUSLY WISHES TO PREVENT THE AUCTIONING OF THE BDC DOCUMENTS IN UTICA AND SEE PROSECUTED ANY INDIVIDUALS IN N.Y. WHO ARE CULPABLE, IT IS EVEN MORE IMPORTANT THAT WE NOT LOSE AN OPPORTUNITY TO SEEK EVIDENCE THAT MAY BE VITAL TO THE RESOLUTION OF THE INVESTIGATION IN BERLIN. IN THIS REGARD, BERLIN PROSECUTORS BELIEVE THAT THE FILES AT MOHAWK ARMS CONTAIN INFORMATION REGARDING MOHAWK'S GERMAN SOURCE FOR THE STOLEN DOCUMENTS, AND WE RENEW OUR RECOMMENDATION THAT US INVESTIGATORS OBTAIN A SEARCH WARRANT AND SEIZE MOHAWK ARM'S CORRESPONDENCE AND OTHER PERTINENT FILES BEFORE THE COMPANY IS ALERTED AND CAN DESTROY INCRIMINATING EVIDENCE.

3. THE FACT THAT THE BDC THEFTS TOOK PLACE WHILE THE ARCHIVES WERE UNDER U.S. ADMINISTRATION, HEIGHTENS THE NEED FOR U.S. AUTHORITIES TO LEAVE NO STONE UNTURNED IN ASSISTING BERLIN PROSECUTORS. MISSION RENEWS ITS OFFER (REF. A) TO SEND THE BDC DIRECTOR TO UTICA, IF NECESSARY, TO PROVIDE TESTIMONY FOR ACQUIRING A SEARCH WARRANT AND TO EXAMINE ANY DOCUMENTATION THAT MIGHT BE SEIZED IN A SEARCH OF MOHAWK ARMS. PLEASE ADVISE. END ACTION REQUESTED.
