1. We apologize for our inability to answer the questions raised in MGQW-15466 any sooner.

2. The following identities of persons have been given by ZIPPER (see attachment 4) to clarify the roles played by the various sources and agents in subject DROLLERIES:

- a. V-2997 is identical with V-2996/10 and with @KUEHNE, fmu (?).
- b. V-2996 is identical with V-2993.5 and with @Walter BELLING.
- c. V-2998 is identical with V-2993.5/KNAPPE, with V-2996/KNAPPE, and with "KNAPPE".
- d. V-2668 is of course @ Kurt GIESECKE, known among other references from MGLA-981 and MKKW-6711.

3. For the true names of the persons listed under a, b, c, and d of paragraph 2 above, see EGLA-686.

4. Two useful previous references on a and b of paragraph 2 above are MGBA-15176 and EGLA-261.

5. According to ZIPPER's memo #3899 (see attachment 4) V-2997 and V-2998 did not know each other.

6. V-2998 failed to return from a meeting in the East sector of Berlin on 9 April 1952. For ZIPPER's account of this and subsequent developments see their memos #2717 and #3076 (Attachments 2 and 3). Of special interest may be paragraphs 4 and 5 of memo #2717 describing the British and French connections of V-2998.

7. We will forward the promised account dealing with "DREESCHETTES" (see paragraph 4, memo #3899 Attachment 4) as soon as it is received by POB.

8. ZIPPER's memo #3200 (see attachment 1) is their -- and GV L's -- answer to our inquiries which were made on the basis of MGBA-15176. In this connection BOB should note that ZIPPER suspects HINDENBERG, fnu, of Berlin-Wilmersdorf, Olivaerplatz to be an AIS agent and probably the person responsible for transmitting the charges against V-2997 to us via BOB.

9. Obviously POB would greatly appreciate receiving BOB's comments on the attached ZIPPER memos, particularly on attachments 1 and 3. Perhaps BOB's CAERE and CABRERIA can shed some light on ZIPPER's activities in these subject cases or, vice-versa the information reported by ZIPPER might serve as a check on their reporting. It seems highly improbable that V-2997 could be identical with CAERE as suggested in MGBA-15176 especially in the light of MGBA-15176.

10. The four ZIPPER memos attached are:

Att. #1. ZIPPER's account of KIRWES and HOEHER including a list of 7 principals more or less involved with Dr. Emil HOFFMANN and operation "DREHSCHLEIBE".

Att. #2 and #3. ZIPPER's account of the disappearance of "KNAPPE", GV L's efforts to learn his fate and of alleged Soviet kidnaping plans in connection with "KNAPPE".

Att. #4. ZIPPER's explanation of the identities and roles played by V-2996, V-2997 and V-2998 in UJ DROLLERY #1004.
