SUBJECT GENERAL Operational/CART
SPECIFIC Dr. Paul Adolf Martin LEVERKUEHN

1. The undersigned has had an opportunity to look up Subject's dossier here and the following points of interest seem to fit in with the UJ DROLLERY 1007/Hermann STEINIGER case.

2. You will recall that LEVERKUEHN was reported in recent contact with Otto WAGNER & DELIUS who know LEVERKUEHN's wartime assistant and friend Ernst Eberhardt MOMM. I believe that UTILITY mentioned that LEVERKUEHN had tried to get MOMM a job with ZIPFER. There seems to be no doubt that LEVERKUEHN and WAGNER worked together to some extent during WWII and the LEVERKUEHN file indicates that WAGNER was to some degree LEVERKUEHN's immediate superior. You will also recall the two points of interest in the case(s) mentioned in paragraph 1, namely:

a. In 1953 MOMM, STEINIGER, KALENDZHEW, and BUCHNER-MAUGEVICH, all, with the exception of STEINIGER, friends of WAGNER, went to Istanbul and were followed there by WAGNER himself. However, STEINIGER and KALENDZHEW were associated in Istanbul.

b. An der Hauptwache 7-8 houses offices of the FERNANDO complex as well as offices of Alfred C. SCHAFER, STEINIGER's Bonn representative, and the Secretariat of the Europe Union, formerly headed by LEVERKUEHN. Further, MOMM's brother was connected in some way with FERNANDO.

3. This year LEVERKUEHN has tried to obtain a visa to the U.S. for his wartime manager of the "Barhardt Bureau" whose head was Lothar EISENTRAEGER, a friend of FERNANDO and Emil Fridolin HOFFMANN in the East-West Trading business.

4. LEVERKUEHN's children, according to his own statement, are in Russia. (COM: See EGQM-11867)
