<p>1. The following SG, BKA report concerning Subject and <i>CIT: Germany & West Germany</i> (Dr) Matthias H. SCHMITT (<i>ministerialrat</i>) DPOB: 14 July 1913 in Krettnach, near Trier <i>Germany</i></p> <p>was received via the local CIC liaison office:</p> <p>"The Federal Prosecuting Attorney General with the Federal High Court was handling investigative proceedings against Dr. SCHMITT on charges of suspected treasonable relations, which were stayed for lack of evidence. There are factual connections between the proceedings against Dr. HOFFMANN and against Dr. SCHMITT. <i>acquaintance of Dr. Emil Fridolin Hoffmann</i> Dr. HOFFMANN was heard as a witness in the Dr. SCHMITT case and stated that he made Dr. SCHMITT's acquaintance at an event of the 'Nauheimer Kreis' (Nauheim Group) in mid-1949. Both had previously been members of the 'Nationalsozialistische Deutsche Studentenbund' (National Socialist German Student Association - NSDStB). It is therefore not impossible that they knew each other prior to 1949. For clarification of this question, material is urgently required which is possibly available at the Berlin Document Center. Would you please send a pertinent inquiry and possibly forward any information which may be available."</p> <p>2. The Bonn CIC liaison office has asked the Berlin Document Center for the desired information.</p> <p>3. CO 513th MI Group has also received a copy of the above report.</p>
