AND CASCOPE IN WHICH CASCOPE THEN PLACED SIMILAR QUERY RE PARA 2 ABOVE ALLEGATION OF AIS INVOLVMENT. ON BASIS FRAN 5921 OF 2 DECEMBER 1961 (NO LONGER AVAILABLE) CASCOPE WAS INFORMED THAT SUBJECT "APPARENTLY NEVER EMPLOYED BY AN AMERICAN AGENCY AND THAT CASCOPE SHOULD QUERY FRENCH FOR ADDITIONAL INFORMATION ON AN INDIVIDUAL POSSIBLY IDENTICAL WITH SUBJECT." CARDED INFO ALSO REFERS TO EGBA-66677 OF 16 DECEMBER 1960 (NO LONGER AVAILABLE) WHICH FORWARDED RESULTS OF BDC TRACES TO CASCOPE.

4. ASIDE FROM FACT CASCOPE CURRENTLY UNAWARE OF 1960-1961 EXCHANGE ON SUBJECT, CURRENT REVIVAL OF CASE MAY INDICATE THAT SUBJECT CAUSING POLITICAL TROUBLE FOR CASCOPE SINCE, IN PRESENTING REQUEST, CASCOPE MENTIONED SUBJECT ASSOCIATED WITH NPD.
