Amt VI Order of Battle

Note: The following paper deals with Amt VI with the exception of the Mil Amt, Gruppe VI S and Gruppe VI Z.

This publication cancels Appendix I to War Room Publication SF.4/22/W.R.O.3a dated 27th July 1945, which now should be destroyed.

This appendix has now been brought up to date, and attempts to cover all Amt VI officers of the following categories:-

- (a) Amt VI officers at the R.S.H.A.
- (b) Amt VI officers on the staff of Bds's.
- (c) Amt VI officers acting as representatives in neutral countries.
- (d) Amt VI representatives in SD-stellen in Germany.

It should be noted that the list does not cover the following classes:-

- (a) Non-commissioned officers; though high grade civilian specialists employed in technical sections are included.
- (b) Officers of Gruppe VI S or VI Z.
- (c) Mil Amt Officers.
- (d) Abwehr officers who have posted to Gruppen of Amt VI as a result of the absorption of the Abwehr.

As is inevitable in a list of this kind there are omissions, but it is not considered that these omissions are either numerous or serious. It is not proposed to issue any subsequent lists of Amt VI officers. A liquidation report on Amt VI, replacing the covering note of the War Room publication mentioned above, is in process of preparation and will be issued when reports on outstanding leading characters are received from the field.

Those personalities considered priority targets are indicated with an asterisk in the appendix.

For easy reference personalities under arrest are underlined in column 2.
