SYNOPSIS OF FACTS: DOC. MICRO. SER. Subject born 12/20/13, Cluj, Roumania. Arrived US on or about 3/13/51 through National Catholic Welfare Conference and was destined to 1367 West 65th St., Cleveland, Ohio. Informant advised that subject stayed in Cleveland for a few days during March, 1951 and that he is presently in Detroit, Michigan working for the Chrysler Corp. Another informant advised that the subject on 9/23/50 and 12/26/50 was reported as being an agent of the Roumanian Intelligence Service. On 11/23/50 he was described as head of the Association of Roumanian Students in Rome Italy. According to informant this association's political orientation was noted as Iron Guardist. Informant advised on 5/14/52 that subject has formed a Social Political Club in Detroit, Michigan which is called "The Friends of the King." <p style="text-align: center;">- P -</p>

I. BACKGROUND

A. Birth Data:

Source: T-1

The informant advised on February 12, 1952 that TIBERIU HUMITA was born on December 20, 1913 in Cluj, Roumania, the son of ~~TEODORE~~ and ~~ABRUJAN ZINUCA~~ HUMITA.

B. Citizenship:

Source: T-2, another Government agency which conducts Intelligence investigations

The subject arrived aboard the "General Muir" at the port of New York on or about March 13, 1951. He arrived under the sponsorship of (Reverend) ~~GEORGE BABUTIU~~ through the National Catholic Welfare Conference and was destined to 1367 West 65th Street, Cleveland, Ohio.

On May 9, 1952, Mr. ARTHUR MILLIRON, a representative of INS, Cleveland, caused a check to be made of INS records concerning the subject with negative results.

C. Present employment and Residences:

On May 14, 1952, Reverend TODERICIOU advised the writer that he succeeded Reverend GEORGE BABUTIU as pastor of St. Helena's Church in Cleveland approximately two years ago. He also advised that the subject arrived in Cleveland during March of 1951 but only stayed for a few days at the end of which time he (HUMITA) left for Detroit.

Informant advised on May 15, 1952 that when the subject arrived in Cleveland during March, 1951, he stayed for a few days and then left for Detroit. According to the informant, the subject is presently working at the Chrysler Corporation in Detroit, Michigan, and also residing somewhere in Detroit.

D. Past employment and residence:

Source: T-1

The informant advised on February 12, 1952 that on October 6, 1949 the subject was the Assistant Chief to IULIU OLTEANU, Chief of Roumanian Security, with offices in the Greek Religious College at Via del Bahhuho 149, Rome, Italy, and at that time resided at Via Corvisieri 13, Rome. According to the informant, the subject reportedly arrived in Italy as a refugee in 1945.

II. CONNECTIONS WITH THE
ROUMANIAN INTELLIGENCE SERVICE

Source: T-1

Informant advised on February 12, 1952 that on September 23, 1950, the subject was reported as being suspected as an agent of the Roumanian Intelligence Service, and that on at least two occasions, information given to him by Roumanian refugees soon appeared in the possession of Roumanian Intelligence Service agents.

On the same date, the informant also advised that on December 26, 1950, HUMITA was reported as a Roumanian Intelligence Service agent in Italy.

III. CONNECTIONS WITH THE IRON GUARD

Informant advised on February 12, 1952 that on November 23, 1950, the subject was described as head of the Association of Roumanian Students in Rome. According to the informant, this association's political orientation was noted as Iron Guardist.

On the same date, informant also advised that on April 18, 1951 HUMITA was reported as, a Horia Sima Iron Guardist, i.e., neo-Fascist and leader of the Iron Guard organization in Italy, the Association of Roumanian Students (Comitato Assistenza Profughi Rumeni), and further that he had already emigrated and is now in the United States.

IV. CURRENT ACTIVITIES

On May 14, 1952, informant advised that he had heard that the subject was in the "Iron Guard." Informant also advised that the subject formed a Social Political Club in Detroit, Michigan, which is called "The Friends of the King." According to the informant one CONSTANTIN MICUDA, who works at the Kaiser-Frazer Corporation, Willow Run, Michigan, helped the subject form the Social Political Club previously mentioned.

Reverend TODERICIOU, as previously mentioned, advised on May 14, 1952, that he met the subject on one occasion during March of 1951, at which time the subject was in Cleveland, Ohio, for a few days. Reverend TODERICIOU added, however, that Reverend GEORGE POP, 13594 Orleans Street, Detroit, Michigan, might know the subject and possibly be in a better position to furnish information concerning the subject. According to Reverend TODERICIOU, the subject may be residing with one Mr. IULIU OLTEANU of Detroit, Michigan, inasmuch as OLTEANU is also a refugee from Italy who arrived in the United States shortly before the subject. Reverend TODERICIOU could not furnish any information concerning the subject's past and present activities.

Informant advised on May 14, 1952, that he has never heard of the subject.
