FROM PALESTINIAN SOURCE FOLLOWING LETTERS CONVERSATIONS WITH LEADING PERSONALITIES IN LEVANT. 1. RELIABLY REPORTED THAT SAMIM BEY AS SUGL RECENTLY RECEIVED LETTER FROM MUFTI STATING FRENCH GOVERNMENT DID NOT OBJECT TO HIS PROPOSED RESIDENCE IN ONE OF MIDDLE EASTERN COUNTRIES, PROVIDED MUFTI APPLIED THROUGH CHANNELS FOR PER- MISSION TO MOVE TO MIDDLE EAST AND MADE HIMSELF RESPONSIBLE FOR SAFEGUARDING HIS LIFE AGAINST ANY JEWISH ATTEMPT ON IT. 2. MUFTI SAID HE PREFERRED TO LIVE IN LEBANON, ONCE FOREIGN TROOPS COMPLETELY WITHDRAWN. HAS REQUESTED SAMIM AS SUHL TO CONFER WITH SYRIAN AND LEBANESE GOVERNMENT IN BEIRUT AND DAMASCUS AND MAKE NECESSARY PREPARATIONS. 3. IZZAT DARWAZAH MANUIN AL MAHDI AND AKRAM ZUAITAR ALSO IN DAMASCUS, REPORTEDLY URGING SYRIANS TO FACILITATE MUFTI'S RETURN. HOPING THEMSELVES TO OBTAIN PALESTINIAN GOVERNMENT'S PERMISSION TO RETURN TO PALESTINE. THIS IS ALL THE INFORMATION PERTINENT. TO THE SUBJECT OF THIS DOCUMENT.
