HAD EGYPTIAN ENTRY VISA #1254 ISSUED BY EGYPTIAN CONSULATE PARIS 2 APRIL 1946. (B) ON 21 JUNE IN PRIVATE CONVERSATION WITH FRIENDS FOREIGN AFFAIRS MINISTER STATED THAT NEITHER PREMIER NOR COUNCIL OF MINISTERS AWARE OF PLANS RE MUFTI AND THAT VERY DISTURBED WHEN LEARNING OF HIS ARRIVAL EGYPT.
