PRESIDENT OF SYBIA IN FAVOR OF WAR AGAINST JEWS IMMEDIATELY BRITISH LEAVE PALESTINE REGARDLESS OF CONSEQUENCES. WANTS TO AVOID FIGHTING WITH BRITISH UNLESS FIRED ON BY THEM.</p> <p>2. CONTINUES TRYING PERSUADE MUFTI ABANDON HIS SELFISH POLICY AND COOPERATE WITH ARAB STATES.
