The Reorganization of the Arab Higher Committee

1. *Haji Amin al-Husayni*, The ex-Mufti <sup>of Jerusalem</sup> has decided to hold a congress in SYRIA, either in September or October, <sup>1951</sup> to be attended by delegates from the Palestinian refugees. In preparation for this Congress, the ex-Mufti in August sent Khalid al-Fassi <sup>al-Fassi, one of his personal messengers</sup> who has been with him in CAIRO for the last two years, on a visit to SYRIA and ~~the~~ LEBANON to make contact with these refugees.

2. ~~At present~~ The first task confronting the Congress will be to elect ~~four~~ <sup>Executive</sup> further five members to the Arab Higher Committee in addition to the five existing members, thus bringing it up to its agreed strength of ten, members including the ex-Mufti.

3. The second task that the Mufti hopes that the Congress will carry out will be to abolish the GAZA Government. The ex-Mufti has quarrelled with Ahmad HILMI Pasha, the head of this Government, and is now planning to delegate its authority to the Arab Higher Committee.

4. Once the Arab Higher <sup>Executive</sup> Committee is at full strength, the ex-Mufti intends to set up bureaux in HEDJAZ, IRAQ and NORTH AFRICA similar to those already existing in BEIRUT and DAMASCUS. He also <sup>intends to create</sup> aims at creating a headquarters in CAIRO which will consist of departments dealing with political affairs, defense, refugees, and finance, and lat

to open propaganda centres in PAKISTAN, INDONESIA, CHINA, and SOUTH AMERICA.

Dissatisfaction with the Arab Countries.

5. The ex-Mufti has lost faith in the Arab countries and relies not on Governments but on the Moslem people as a whole. He is particularly interested in promoting congresses similar to the Economic Congress of the Moslem World recently held in KARACHI, and intends to establish a political body which will claim the support of Moslems all over the world.

6. As a first step towards the realization of this idea, the ex-Mufti sent <sup>Abd-al</sup> ~~Abdul~~-Jalil SUKKAR, employed by an aircraft company in CAIRO, to IRAN in early July. SUKKAR was the bearer of a letter addressed to <sup>Mullah</sup> ~~Agwan~~-KASHANI, the Iranian religious leader, in which the ex-Mufti suggested that KASHANI should be appointed the first honorary president of the <sup>of</sup> ~~IKHWAN~~-~~MUSLIMIN~~ for the entire Moslem world. KASHANI agreed to this proposal.

~~Contacts with the Greek Orthodox Patriarch of ANTIQCH~~

7. <sup>Amil Sher.</sup> ~~Emil~~ GHOURI was instructed by the ex-Mufti to contact the Greek Orthodox Patriarch of ANTIQCH on the latter's return from RUSSIA. The purpose of the visit would be to discover what the Patriarch had accomplished during his stay in RUSSIA.

~~Contacts with the Lebanese Prime Minister~~

8. During his stay in ALEXANDRIA for the meeting of the Political Committee of the Arab League, Abdallah YAFI, the Lebanese Prime Minister, accompanied by Charles <sup>Hila</sup> ~~HEOU~~, the Lebanese Minister for Foreign Affairs, received a visit from the ex-Mufti. <sup>with Mr. Palle.</sup> ~~The~~ requested that in the forthcoming meetings in PARIS of the Palestine Conciliation Commission, the Lebanese representative should propose that the 1947 <sup>(United Nations)</sup> ~~UNSCOP~~ decisions should be enforced. The ex-Mufti added that he would never accept the transfer of refugees to SINAI, but that he did not mind if they were sent to SYRIA or ~~the~~ LEBANON.

9. <sup>(Husayni)</sup> Immediately after the murder of King ABDULLAH, the ex-Mufti sent <sup>Salim al-Husayni</sup> ~~Salim al-HUSAYNI~~ to DAMASCUS on a special assignment to organize and lead a movement in SYRIA supporting the annexation of JORDAN to SYRIA.

~~Contact with PAKISTANI~~

10. At the beginning of August, <sup>Husayni</sup> RAJAI ~~HUSAYNI~~ one of the ex-Mufti's active supporters, in CAIRO, delivered a letter from the ex-Mufti to Hajj Khalil TABBARAH, a Beirut businessman who contracts for the transport of pilgrims to the various shrines. On receipt of this letter, TABBARAH went to IRAN where he gave a letter to KASHANI. In this letter, the ex-Mufti urged KASHANI to encourage support for EGYPT in the question of the Suez Canal dispute. The ex-Mufti also enclosed a letter addressed to AMAL-ULLAH, the Secretary of the KARACHI Moslem Congress. The reason that this letter was not handed to the Pakistani Minister in CAIRO was <sup>(3)</sup> the ex-Mufti's mistrust of the letter on the grounds that he was pro-British.
