1. ON INITIATIVE OF GRAND MUFTI HAD TWO MEETINGS WITH HIM. IS CONCERNED OVER INTEREST SHOWN AND HAS IMPRESSION HE CHECKED ON HIM WITH SOMEONE IN INDONESIA AFTER FIRST MEETING. TOLD SUBJECT HE WAS MORE TRUSTED BY SOME INDONESIAN LEADERS THAN MEN OF OWN RACE. SUBJECT COULD NOT GET GRAND MUFTI ELABORATE.
