THE THIRD PARAGRAPH OF THIS MESSAGE SHOULD BE CORRECTED TO READ AS FOLLOWS:

2. MUFTI'S CURRENT CRAZE IS A UNITED ISLAMIC MOVEMENT, PROBABLY HEADED BY HIMSELF, DESIGNED TO EXTORT CONCESSIONS FROM EAST AND WEST. HE AND KASHANI EXCHANGED IDEAS THIS SUBJECT RECENTLY IN LEBANON. MUFTI REPORTEDLY COUNTS HEAVILY ON SUPPORT FROM NAGUIB, SHISHIKLI, MOSADEQ AND PAKISTAN. BOTH KASHANI AND MUFTI AGREE REGENT AND NURI SAID MUST BE ELIMINATED BEFORE ISLAMIC MOVEMENT CAN MAKE PROPER HEADWAY IN IRAQ. PLEASED BY INITIAL INTERVIEW, MUFTI PLANS ANOTHER DISCUSSION WITH SHISHIKLI UPON HIS RETURN FROM CAIRO AFTER ARAB LEAGUE MEETING.
