SOURCE (EVALUATION DEFINITIVE) AN OFFICIAL WEST GERMAN SERVICE, FROM A SOURCE DESCRIBED AS FAIRLY RELIABLE WITH CONTACTS IN CAIRO. THE OFFICE OF THE GRAND MUFTI (HAJJ) AMIN AL-HUSAYNI HAS WORKED OUT PLANS FOR THE CREATION OF AN INDEPENDENT PALESTINE. THE WEST JORDAN AREA ANNEXED IN 1950 BY JORDAN WOULD BE THE NUCLEUS FOR THIS STATE. THE GRAND MUFTI'S FOLLOWERS BELIEVE IT IS PROBABLE THAT THE U.S.S.R. WILL INTRODUCE THE PALESTINE PROBLEM IN THE NEXT SESSION OF THE U.N. GENERAL ASSEMBLY AND WILL SUPPORT THE PARTITION PROPOSALS MADE IN 1950, THEREBY ASSURING A MAJORITY IN FAVOR OF THESE PROPOSALS.
