ON 9 SEPT KING HUSAYN VISITED BY MUNIF HUSAYNI, RELATIVE AND FOLLOWER OF EX GRAND MUFTI, WHO REITERATED SENSE OF LETTER AND SPEAKING ON BEHALF OF HAJJ AMIN HUSAYNI AND HIS FOLLOWERS SAID HE FELT THERE SHOULD BE CLOSER CONTACT BETWEEN THEM AND JORDANIAN GOVT. WORK TOWARDS ESTABLISHMENT OF SEPARATE PALESTINE GOVT AND ARMY, WHICH, MIN INTERIOR SAID, WOULD HAVE SUPPORTED BY PRES JAMAL ABD AL NASIR. MUNIF HUSAYNI SAID THAT HAJJ AMIN HAD REFUSED REQUEST ON GROUNDS IT FIRST OF ALL UNFAIR TO JORDAN AND BECAUSE ESTABLISHMENT OF SEPARATE GOVT WOULD BE PREJUDICIAL TO ULTIMATE SETTLEMENT OF REFUGEE PROBLEM.
