14. HUSAYNI, HAJJ AMIN AL C] DESPITE ALL OF HIS DENIALS IT HAS BEEN CONFIRMED THAT HE IS BRITISH AGENT NO.1 AND CRIMINAL NO. 1. HE IS DETESTED BY THE IMPORTANT PALESTINIAN FAMILIES BECAUSE THEY ACCUSE HIM OF ASSASSINATING MANY OF THEIR MEMBERS DURING THE BRITISH MANDATE IN PALESTINE. HIS FINANCIAL SOURCES ARE IRAQ, PAKISTAN, LIBYA AND TUNISIA. HE SPENDS ON THE LEADING MEMBERS OF THE HIGHER ARAB COMITE TO MAINTAIN THEIR LOYALTY TO HIM; AND THE DISTRIBUTION OF THE COMITE'S MEMBERSHIP IN THE VARIOUS ARAB STATES CONSTITUTES A NET WORK WORKING FOR HIM. HE ALLEGES THAT HE IS INTERESTED IN THE LIBERATION OF PALESTINE AND IS WORKING TOWARD THAT END. IN AGREEMENT WITH THE BRITISH IN ORDER TO FOOL THE SIMPLE PUBLIC OPINION WHICH HE IS IN NEED OF. THE LIBERATION IS ABSOLUTELY NOT A SUBJECT OF CONSIDERATION AS FAR AS HE IS CONCERNED, AND HIS INTEREST IS MERELY IN MAINTAINING HIS PERSONAL PRESTIGE. CIRCULARS WHICH HAVE BEEN DISTRIBUTED WERE MERELY A COVER FOR THE RECENT INCIDENT WHICH HAS BEEN CONFIRMED AS WAS ALSO CONFIRMED HIS PRESENT PROGRAM OF TAKING A STAND AGAINST THE NATIONALIST CURRENT.
