FIELD REPORT NO.

1. SOURCE COMMENT: HAJ AMIN AL HUSAYNI WAS IN RIYADH FROM 6 THROUGH 17 JANUARY FOR DISCUSSIONS WITH KING FAYSAL AND FOR THE PURPOSE OF COLLECTING THE ANNUAL SAUDI SUBSIDY TO THE ARAB HIGHER COMMITTEE (AHC) ON PALESTINE.

2. THE ANNUAL SAUDI SUBSIDY TO THE ARAB HIGHER COMMITTEE IS SAUDI RIYALS ~~200,000~~ (1\$-4.5SR) AND IS NORMALLY PAID DURING THE MONTH OF RAMADAN. DURING HAJ AMIN'S VISIT TO RIYADH THIS YEAR, HE MET WITH KING FAYSAL AND AMIR MUSAID IBN ABD AL RAHMAN, THE MINISTER OF FINANCE, AND REQUESTED AN INCREASE IN THE ANNUAL SUBSIDY IN ORDER THAT HE COULD "COMBAT SHUKHAYRI". KING FAYSAL REPORTED

THAT SAUDI ARABIA FELT IT NECESSARY TO REVIEW THE STANDING PRACTICE OF THE GOVERNMENT REGARDING THE SUBSIDY ALREADY BEING PROVIDED AND THAT, IN ANY CASE, AN INCREASE IN THE SUBSIDY WAS OUT OF THE QUESTION "AT THIS TIME". KING FAYSAL ADDED THAT IT SEEMED TO HIM THAT AHMAD SHUKHAYRI HAD EMERGED AS THE LEADING FIGURE OF THE PALESTINIAN LIBERATION MOVEMENT AND THAT THE ARAB HIGHER COMMITTEE APPEARED TO BE FLOUNDERING ABOUT WITH NO PRECONCEIVED POLICY OR PLAN OF ACTION. FAYSAL ASKED HAJ AMIN IF THE AHC HAD PLANS TO DO MORE WITH THE REQUESTED ADDITIONAL SUBSIDY, AND IF SO, WHAT WERE THESE PLANS; WHAT IS THE LONG RANGE POLICY OF THE AHC. HAJ AMIN REPLIED THAT HIS COMMITTEE WAS WORKING ON A NEW POLICY FOR PALESTINE LIBERATION AND THAT HE WOULD PREFER TO PRESENT THIS PLAN TO KING FAYSAL AFTER COMPLETION OF THIS YEAR'S HAJ. (FIELD COMMENT: THE HAJ THIS YEAR FALLS ON 10 AND 11 MARCH), HAJ AMIN DEPARTED SAUDI ARABIA ON 17 JANUARY WITHOUT HAVING RECEIVED THE ANNUAL SUBSIDY PAYMENT. (SOURCE COMMENT: KING FAYSAL DETESTS AHMAD SHUKHAYRI AND THE PALESTINE LIBERATION ORGANIZATION (PLO) AND HE IS PROVIDING ONLY LIMITED SUPPORT TO THIS ORGANIZATION IN ORDER TO KEEP HIS FENCES MENDED WITH OTHER ARAB COUNTRIES. FAYSAL'S PURPOSE IN PROVOKING HAJ AMIN MUSAYNI IS TO STIR UP SOME ACTION WITHIN THE ARAB HIGHER COMMITTEE WHICH COULD WORK TO THE DETRIMENT OF THE PLO AND SHUKHAYRI).
