OFFICIALS. TAL MADE THESE STATEMENTS IN THE PRESENCE
OF SEVERAL OTHER SENIOR GOJ OFFICIALS.

1. (FIELD COMMENT: THERE HAVE BEEN SEVERAL RECENT AREA
PRESS REPORTS THAT THE GRAND MUFTI, HAJ AMIN HUSAYNI, AT THE
INVITATION OF THE GOVERNMENT OF JORDAN (GOJ), PLANS TO MOVE
FROM BEIRUT TO JERUSALEM IN THE NEAR FUTURE. THERE HAS BEEN
CONSIDERABLE SPECULATION THAT THIS IS A JOINT GOJ/HUSAYNI
POLITICAL MOVE TO BUILD A PRO-GOJ PALESTINIAN BASE IN JORDAN,
UNDER HUSAYNI, AS A COUNTER WEIGHT TO AHMAD SHUQAYRI AND THE
PALESTINE LIBERATION ORGANIZATION (PLO).)

2. THE GOJ HAS PROVIDED LIMITED SUPPORT TO HUSAYNI'S ARAB HIGHER COMMITTEE IN THE PAST AS A COUNTER TO SHUQAYRI AND THE PLO. THIS WILL BE CONTINUED, BUT IT IS A MINOR PROJECT IN TERMS OF JORDAN, THE PALESTINIANS AND THE PLO. AS A RESULT OF THE RECENT DISINTEGRATION OF THE PLO AND SHUQAYRI'S LEADERSHIP, NEITHER SHUQAYRI NOR HIS ORGANIZATION ARE CONSIDERED A THREAT TO JORDAN. THUS, THE GOJ HAS NO NEED TO TAKE ANY SERIOUS STEPS THROUGH HUSAYNI OR ANYONE ELSE TO CREATE A POLITICAL COUNTERWEIGHT TO SHUQAYRI. MOREOVER, HUSAYNI IS NOT POPULAR IN MANY CIRCLES, IS GENERALLY DISCREDITED, AND COULD BE A SOURCE OF PROBLEMS AND A LIABILITY TO THE GOJ IF HE WERE GIVEN TOO MUCH LICENSE. HUSAYNI WILL COME TO JORDAN FOR A BRIEF VISIT IN EARLY MARCH. HE ASKED GOJ PERMISSION TO VISIT JERUSALEM OVER THE ID AL FITR FEAST IN MID-JANUARY. PERMISSION WAS GRANTED BY KING HUSAYN, BUT HUSAYNI DID NOT ARRIVE. HE HAS NOW ADVISED THE GOJ THAT HE WILL STOP IN JORDAN ON HIS WAY TO MAKE THE HAJ IN SAUDI ARABIA. BUT HIS STAY IN JORDAN WILL HAVE NO POLITICAL SIGNIFICANCE AND THE GOJ IS INDIFFERENT TOWARDS HIS VISIT. (FIELD COMMENT: TOP JORDANIAN MILITARY AND SECURITY OFFICERS ARE OPPOSED TO HUSAYNI'S VISIT OR ANY DEALING WITH HIM.)

(FIELD COMMENT: A FAIRLY RELIABLE SOURCE CLOSE TO HUSAYNI AND HIS FOLLOWERS CLAIMS THAT TAL IS PRIVATELY ENCOURAGING HUSAYNI TO INCREASE HIS INFLUENCE AMONG WEST BANK PALESTINIANS IN THE HOPE THAT TAL, THROUGH HUSAYNI, CAN DEVELOP A PERSONAL POLITICAL BASE ON THE WEST BANK WHICH TAL CAN EXPLOIT FOR HIS OWN POLITICAL AMBITIONS.)

4. (FIELD COMMENT: IT IS POSSIBLE THAT THIS IS TAL'S PRIVATE HOPE BUT HE HAS TAKEN A CONTRARY POSITION IN FRONT OF OTHER SENIOR JORDANIAN OFFICIALS WHO ALSO SHARE THIS VIEW. THIS COMBINATION OF FACTORS SHOULD PRECLUDE HUSAYNI FROM ASSUMING ANY IMPORTANT ROLE OR UNDERTAKING ANY SIGNIFICANT ACTIVITIES IN JORDAN.)
